



Q2 If you are in private practice, please select one:



Q3 How long have you been in practice?







Q7 Have you attended a MPS sponsored education activity in the past year?



Q8 If no, why not? (Check all that apply)







Q14 Are you involved in telepsychiatry?



Q15 If yes, is patient privacy a concern?



Q16 Do you accept insurances?



Q17 If yes, which do you accept?



Q18 What is your overall level of satisfaction with the MPS?


