Jack Drescher, MD, is a psychiatrist and psychoanalyst in private practice in New York City. He served as a member of APA's DSM-5 Workgroup on Sexual and Gender Identity Disorders. He has edited and co-edited more than a score of books dealing with gender, sexuality and the health and mental health of LGBT communities, most recently *The LGBT Casebook* (2012, American Psychiatric Publishing) and *Treating Transgender Children and Adolescents* (2013, Routledge). In the 10th edition, Dr. Drescher is senior author of the chapter on "Gender Identity, Gender Variance and Gender Dysphoria." Dr. Drescher is an expert media spokesperson on issues related to gender and sexuality. He has appeared on numerous television networks.

Elyse Pine, M.D. - is a board certified pediatric endocrinologist at Chase Brexton Health Care in Maryland. Dr. Pine began working with gender variant children and adolescents when she started working at the University of Maryland, and it has been the most interesting, exciting and rewarding part of her clinical practice. She now focuses on the healthcare needs of transgender and gender-expansive youth.

Hariette Wimms, Ph.D. - has worked with individuals, children, families, schools, and community agencies throughout Baltimore and surrounding areas for over 20 years. She is currently the developer and director of the Child, Adolescent, and Family Behavioral Health Program at Chase Brexton Health Care and specializes in the areas of gender diverse youth, grief and loss, stress reduction, bullying prevention and reduction, social-emotional learning, and coping with childhood trauma.
