Session Objectives

Psychiatrists and Guns: Can We Ask, Do We Care and Should Our Guild Opine?

James S. Reinhard, MD, DFAPA

At the end of this session the participant should:

Expanding the Virginia Medicaid Substance Use Disorder Benefit: Integrating Medication Assisted Treatment Management into Your Practice
