## **2014-2015 MPS Initiatives**

During the 2015 Maryland General Assembly, MPS members **met with over 20 key legislators** during Advocacy Days, February 4 and 5. Over 95 bills were reviewed. Testimony and written positions were provided on 12 bills that affected psychiatry. Some major successes include:

- ♦ Helped defeat legislation that would have allowed physician assisted suicide without an evaluation of the patient.
- Advocated for inclusion and received a representative on the Maternal Mental Health Task Force.
- ◆Strongly supported legislation requiring an annual review of network adequacy for health insurance panels.
- ♦ Assisted in defeating a Prescription Drug Monitoring Program that would have proven onerous.

Launched **new website**, which will soon give members the ability to update their profile and pay dues online.

Worked actively on integration of mental health and substance abuse services into the **Maryland Behavioral Health Administration**.

Participated as a stakeholder in considering proposals for **Outpatient Civil Commitment** in Maryland.

Provided testimony regarding regulations implementing **Medical Marijuana** in our state.

Held **5 MOC trainings** and a symposium on women's mental health with mandated **opioid prescribing CME**.

Participated in the revision of Maryland's **Uniform Treatment Plan Form** and notified members of the new form.

Explained how members can review and correct **information posted online about physicians** in Open Payments, Physician Compare, Part D Prescriptions, and Health Insurer Provider Directories and Physician Rating Systems.

Added a voting Resident-Fellow Member on MPS Council.
