



# Q1 Please describe your practice


# Q2 If you are in private practice, is it:



# Q6 What CME Events Would You Be Most Likely To Attend? (Check all that apply.





## Q7 Have You Visited the MPS Website In The Past Year?





## Q9 What MPS Website Content Is Of The Most Interest To You? (Please check all that apply)



## Q10 Have You Registered On The MPS Website For A Member Account? (If yes, please skip next question.)








