#### A Winter's Tale

Though the hard chill of winter hasn't descended upon the Chesapeake region yet, everything tells us the time is near. The shortening of daylight hours always takes me by surprise and, at least in my back yard, the birds dwindle in number and the squirrels increase in girth. These changes are also a reminder that episodes of seasonal affective disorder are on the rise. In addition, I've come to appreciate over the years how feelings of grief can be overwhelming over the holidays when loved ones are absent. Now is a time to be particularly attentive and generous to one another.

Winter at the MPS has a particular cadence – like a flash, the legislative session in Annapolis opens in the beginning of January and hurtles ahead at breakneck speed until April. Already, the MPS and Legislative Committee Chair Anne Hanson, M.D. are laying the groundwork with recruitment of new members, a kick-off orientation (held on November 20) and getting the word out. Accordingly, I've asked Anne to add a few words to this column . . .

The MPS Legislative Committee is comprised of members at every career stage, including residents and fellows. The committee volunteers time to review literally hundreds of pieces of legislation during the Maryland General Assembly, which runs from January to early April. Proposed laws address many issues relevant to our members: insurance coverage and parity, preauthorization, access to care, mandatory reporting and licensure, and involuntary treatment standards.

No specific training is required to be a member of the committee. Aside from

one in-person meeting in the fall, most work is done virtually through a weekly conference call during the session. Members have the opportunity to write testimony, propose amendments, and to go to Annapolis to testify in person on select bills. Our lobbyist works closely with members to refine testimony and to work behind the scenes in between conference calls.

**December 2019** 

The 2020 session promises to be another busy one. The governor's executive order to study the state mental health system this year will likely lead to several bills that will reorganize and integrate medical, psychiatric, and substance abuse services. Members who want to have some influence in this process should consider joining the Legislative Committee. (Thank you, Anne.)

The success of the Legislative Committee's efforts depends on myriad factors. One underappreciated factor of that success is the activity of the Maryland Psychiatric Political Action Committee (MPPAC), which represents the interests of organized psychiatry In Maryland especially on behalf of those who are reluctant to participate in political campaigns. The MPPAC exists to make campaign contributions and to connect psychiatrist constituents with their state representatives who decide on bills affecting psychiatric practice and patients. This is a rebuilding year and if you are interested in providing input (and contributing your time) so that Maryland laws better reflect your and your patients' priorities, then this is the time to step up. A simple phone call to the MPS at 410-625-0232 will get you started.

## MPS Member Publication: Dr. Negro

In February, **Paulo J. Negro, MD PhD FAPA FASAM** published A BLUEPRINT FOR THE HARD PROBLEM OF CONSCIOUSNESS: Potential States, Strange Loops and The Realization of Information from Cells to Human Consciousness.

The book addresses the fundamental mechanism that allows physical events to transcend into subjective experiences, termed the Hard Problem of Consciousness. It avoids the panpsychism underlying other models for the Hard Problem. The key feature of this blueprint is that it offers a perspective of the Hard Problem of Consciousness from the point of view of the subject; the experience of 'being the subject' is predicted to be the realization of inference inversely mapped out of hidden causes of global integrated actions.

## November 12th Council Highlights

#### **Ideas to Support MPS Strategic Priorities**

Dr. McGuire stated that ideas and progress on the priorities that Council established in September will be a regular item for Council input:

- Membership growth & retention particularly early career psychiatrists
- Member engagement including WPS and leadership development
- Financial enhancement focused on non-dues income sources

Dr. Ehrenreich reviewed the ideas generated at the October meeting of MPS committee chairs. For example, the Academic Psychiatry Committee is beginning to publicize members who have published recently as a means of increasing member engagement with the organization as well as with each other. Another idea is a "light" form of mentorship where younger members can engage informally with more experienced members around various career topics like establishing a practice, employment contracts, etc. Dr. McGuire asked that Council take time to brainstorm about ways to build on these ideas or come up with new ones that can move the MPS closer to its goals.

Dr. Merkel-Keller suggested that MPS expand its role in helping employers connect with psychiatrists looking for positions, similar to how locums firms try to engage psychiatrists for their clients. This "match-making" could take several forms in addition to the usual position ads, eblasts and career and practice night. For example, a job board would allow members to post their CVs in addition to the current paid listings of position openings. Finding the right corporate connections is key. These activities would increase nondues income while serving members' professional needs.

#### **Executive Committee Report**

Dr. Ehrenreich reported that the MPS now has eight Interest Groups. He noted copies of letters that MPS signed on to: Behavioral Health Coalition recommendations for the BH System of Care and MedChi's request that Medicaid rates be restored to 100% of Medicare. He said the Maryland Foundation for Psychiatry agreed to fund cash poster and paper award prizes and MPS annual dinner tickets for the winners, as well as a \$1000 grant for Gun Violence CME in April 2020.

Then Dr. McGuire gave an update on the Washington Psychiatric Society (WPS) situation discussed in September. Given the lack of response from WPS or APA and the approaching Maryland legislative session, he had two conversations with WPS President Phil Candilis. Dr. Candilis explained that he is moving the MOU (in its original draft form) through the necessary board actions and that further changes would need to be considered after the coming WPS election. At this point, the MPS is continuing with last year's MPS legislative advocacy and lobbyist, and the resulting financial deficit. Dr.

McGuire requested Council input about possibly moving to a Plan B. After discussion, Council voted to do nothing now and wait for WPS leadership to respond.

Dr. McGuire stated that Scott Hagaman, M.D. is stepping down as Maryland Psychiatric Political Action Committee Chair and a new chair is needed beginning in January. A request for MPPAC volunteers will be posted on the listserv.

#### Secretary-Treasurer's Report

Dr. Ashley noted that as of September 30, MPS current assets and liabilities are up \$18K compared with last year, mostly because MPS billed 2020 dues instead of APA. She reported that the annual investment policy calculations indicate that \$3K must be added to the emergency reserve and \$9K can be added to the investment reserve. Compared to budget to date, the \$9K deficit is \$1K better than expected, although it is \$18K worse than last year's. After accounting for the October and November events, the 2019 financial picture will be clearer, but in any event the MPS has ample assets for current operations. The 2020 capital budget rolls funds already approved, but unspent, for a computer network to next year. Council voted to approve the report.

#### **Executive Director's Report**

Ms. Bunes said that data intern Joanna An started October 1, helping the MPS complete a database of licensed psychiatrists that will be used for event promotion, member recruiting, etc. All voting Council members and committee chairs have returned disclosure forms (nothing unexpected to report). As of that day, the MPS had collected about half of the 2020 dues billed. The MPS provided lunches for the Hopkins and Maryland/Sheppard residency programs and distributed info and resources. The October 17 networking event included food, drinks, colleagues and career/practice information. Medicaid Provider Services asked that MPS assist with notifying individual psychiatrists who are not currently enrolled as a rendering or an ORP provider. They will delay enforcement of the enrollment requirement until next year. Meagan Floyd will attend the APA DB Execs meetings. Ms. Bunes attended the MedChi House of Delegates to meet AMA President Patrice Harris, M.D. and connect with MPS members.

#### Nominations & Elections Committee Report

Dr. Palmer distributed the committee's recommended slate for the 2020 MPS elections. Please see <u>page 4</u> for details. The slate and Council nominations for Assembly Representative and Nominations & Elections Committee were approved.

#### MedChi Delegate's Report

#### **New Business**

Ms. Bunes left the room and Dr. McGuire reported that the Executive Committee recommends \$2500 salary increases for

staff in 2020. The budget allows for \$9K, leaving \$4K for possible shortfalls, bonuses or other staff needs. 2018 comparative data from Maryland Nonprofits' Salary Survey support the increases. Council voted to approve the salaries.

The Maryland Foundation for Psychiatry seeks approval for the addition of Theodora Balis, M.D. to its Board of Directors. Council voted to approve the appointment.

# MHCC Psychiatric Services Clinical Advisory Group

The Maryland Health Care Commission held two meetings of its clinical advisory group (CAG) in November. As part of its review of the State Health Plan and Certificate of Need requirements, MHCC is working to define the need for acute psychiatric services in the state. Several MPS members serve on the CAG, including Stephanie Knight, M.D., who also serves on the MHCC Psychiatric Services Workgroup. ## Health Insurance Study

The Maryland Insurance Administration, in conjunction with the University of Baltimore, is conducting a study to explore why some individuals don't buy health insurance and why some other individuals who have health insurance don't use their benefits in Maryland. Focus groups with Marylanders in different locations across the state will also be part of the study, which is fully funded (100%) by a grant from the U.S. Dept. of Health and Human Services.

# MPS Advocacy on Medicaid and Public Sector

In November 2019, the MPS signed on to two important initiatives that affect Maryland's public behavioral health system.

The MPS signed on to a letter to Governor Hogan urging that Medicaid reimbursement be one of his budget priorities for FY 2021. A group of health care providers coordinated by MedChi are advocating that reimbursement for Medicaid E&M codes be equivalent to Medicare reimbursement rates. The enhanced rates are expected to improve both health care practitioner participation in Medicaid and patient access to care, while reducing unnecessary hospital utilization. We also signed on to the Maryland Behavioral Health Coalition's <u>recommended system of care improvements</u>. This is in response to the Maryland Department of Health's undertaking that examines how the state should provide, administer and finance public mental health and substance use services, with an aim to identify solutions that increase the coordination and quality of somatic and behavioral health care for Medicaid enrollees, ensure cost efficiencies, and promote access to care.

Finally, MPS and MedChi have officially adopted <u>principles</u> for the integration of mental health and substance use disorder treatment with somatic care. These will guide advocacy efforts and responses to proposed legislation.

# MPS Adopts Position on Integration

The health care system in Maryland faces challenges on multiple fronts. One of them is fragmented systems of care. In 2019, the Maryland Department of Health initiated a two-year process of exploring changes to the public and private healthcare delivery systems. At its November 12 meeting, the MPS Council approved a position statement with guiding principles that include:

- patient-centeredness,
- adequate continuum of community-based services, including psychiatric rehabilitation,
- quality integrated care management and care coordination,
- stakeholder oversight and data transparency,
- accountable parity compliance,
- provider communication,
- transparent network adequacy,
- · patient- and provider-friendly reimbursement processes,
- minimization of administrative overhead, and
- payor and provider incentives to coordinate and to promote positive outcomes and prevent negative outcomes and to control unnecessary costs.

The MPS will work to ensure that Maryland citizens have unfettered and timely access to comprehensive, coordinated, evidence-based, quality treatment and recovery services for mental health and substance use disorders in both primary and specialty care settings.

# Public Behavioral Health System ASO Transition

Effective January 1, 2020, Optum Maryland will replace Beacon as the administrative service organization (ASO) for Maryland's public behavioral health system. Before then, you need to:

- 1) **SIGN UP FOR TRAINING** with Optum—go to <a href="https://mmcp.health.maryland.gov/Pages/Administrative-Service-Organization-Transition-Information-.aspx">https://mmcp.health.maryland.gov/Pages/Administrative-Service-Organization-Transition-Information-.aspx</a>.
- 2) **REGISTER** with Optum—look for a provider alert when the portal is live (expected Dec. 16th). Existing authorizations will transfer to Optum, but providers still need to register to continue authorizations and submit claims.
- 3) **PREPARE** for payment—make sure your "Pay To" or "Remit To" address in Medicaid (MMIS) is 100% accurate and ensure that your provider file in Medicaid (through ePREP <a href="https://eprep.health.maryland.gov/sso/login.do">https://eprep.health.maryland.gov/sso/login.do</a>) is up to date.

# November MedChi House of Delegates Highlights

At the November 2 House of Delegates meeting, Drs. Shaya, Daviss and Allen worked to pass the MPS resolution (29-19), Integration of Mental Health, Substance Use, and Primary Care Systems and Services. Some of the reference committee members wanted MedChi to have more latitude in responding to proposals, so the resolution was amended so that MedChi supports the principles while monitoring related legislation and regulatory changes. The MPS members who negotiated the change, including Drs. Tom Allen, Steve Daviss and Elias Shaya, thought this result is stronger than what MPS submitted.

The House of Delegates also voted to support a resolution (24-19), *Outpatient Mental Health Clinic Medical Directors*, which establishes MedChi policy that the OMHC medical director must be a physician. This was a response to the 2019 passage of a bill dropping the requirement for the medical director to be a psychiatrist and allowing nurse practitioners to serve as "medical directors."

Also of interest, the MedChi HOD approved a resolution (14 -19), Gun Violence and Mental Illness Stigma in the Media. The MPS alerted APA Delegates to the AMA that Maryland forwarded the <u>resolution</u> to the AMA House of Delegates, and suggested it have their support.

## November APA Assembly Highlights

The Assembly of the American Psychiatric Association met November 15-17 to vote on twenty-two position statements and fourteen action papers. Some highlights of these actions are below.

The Assembly voted to either retain or revise position statements related to prescription drug monitoring programs, principles for end-of-life care, discrimination in insurance coverage, racial disparity and diversity in mental health services, and psychiatric participation in interrogation and torture. Action Papers that were approved by the Assembly include:

- Two papers related to climate change. The first paper requires the APA to join as signatory to the U.S. Call to Action on Climate, Health and Equity. The second paper asked the APA to implement a policy to off-set carbon emissions for all APA-related travel.
- Another action paper asks the APA to lobby the National Alliance of State Pharmacy Associations to encourage all pharmacies to provide information about local medication collection sites in order to improve disposal of controlled substances.
- The Assembly passed a paper to create a resource document regarding national temporary detention laws and practices.

Papers were also passed to oppose certain issues:

- The Assembly called upon the APA to require the Social Security Administration to enforce federal guidelines regarding disability evaluations. This paper was in response to one district branch in which chiropractors were evaluating claimants based upon mental illness.
- The most controversial paper involved a proposal to allow affiliate membership in the APA by nonphysicians. The Assembly passed a paper opposing creation of affiliate memberships.

A workgroup has been formed to revise a position statement on safe prescribing by non-physicians. The revised position statement is due back to the Assembly in September 2020.

The Assembly voted to approve the revised guidelines for the treatment of schizophrenia. The draft guideline was distributed for public comment in May 2019, and the final version will soon be available at <a href="https://www.psychiatry.org/psychiatrists/practice/clinical-practice-quidelines">https://www.psychiatry.org/psychiatrists/practice/clinical-practice-quidelines</a>.

The Assembly voted to approve revisions to DSM-5, specifically modifications to Avoidant/Restrictive Food Intake Dis-

order (ARFID), substance or medication-induced disorders, and narcolepsy subtypes. The DSM-5 has also been revised to re-include the diagnosis of unspecified mood disorder.

Within Area 3, the New Jersey District Branch will give a presentation at the next meeting about model legislation to limit pre-authorization requirements.

The APA Committee on Maintenance of Certification accepted feedback regarding the alternative ABPN certification process, and is currently discussing a possible free APA-sponsored certification program.

## APA Comments on Changes to 42 CFR

In August, SAMHSA released Proposed Rule changes to 42 CFR Part 2, which governs confidentiality for substance use disorder (SUD) patient records, to better align Part 2 with Health Insurance Portability and Accountability Act (HIPAA). Under this proposal, the structure of the confidentiality requirements would not change, and patient consent would be required, other than for statutory exceptions (medical emergencies, scientific research, audit or program evaluation, or a court order). The APA supports the additional flexibility, but urges additional changes to allow clinicians to receive a general consent for information to be disclosed and redisclosed for the purposes of treatment, payment, and health care operations among entities covered under HIPAA, while strengthening protections against inappropriate sharing of treatment records with law enforcement, attorneys, employers, and others. As Part 2 becomes better aligned with HIPAA, APA requested, in its comments, that breach notification and penalties required under HIPAA also be aligned. APA also submitted separate comments opposing a proposal to expand the definition of "an extremely serious crime". Full APA comments are available here.

# APA Advocacy on Parity

The APA released a statement urging action to end disparities in mental health coverage in the wake of a report released by Milliman, Inc. The report, which covered calendar years 2016 and 2017, showed that people seeking treatment for mental illness and substance use disorders continue to pay more and face more barriers to accessing care than those seeking care for physical illness. Patients using commercial PPO health plans were more likely to pay out of pocket for mental health care compared to general medical care, and that primary care reimbursement rates were higher than behavioral health reimbursements. # **Medicare Updates**

# AMA Update on the 2020 Medicare Fee Schedule

The 2020 Medicare physician payment schedule contains news about coding revisions for outpatient <u>evaluation and management</u> (E/M) services that promise to greatly reduce administrative burdens for physicians in 2021. But the 2,475-page document also contains information on a multitude of tweaks to the Medicare Quality Payment Program (QPP) and a plethora of other details affecting how physicians will be paid by Medicare starting January 1.

The AMA's experts have prepared a summary of the <u>2020</u> changes to <u>QPP</u> and <u>Medicare physician payment</u>. Here are five things physicians need to know:

- A heavier lift will be required to avoid a MIPS penalty
- MIPS high-performer threshold goes up
- No change to MIPS cost and quality weights
- Framework to cut MIPS burdens
- APM 2022 payments estimated, 2019 payments paid

#### Medicare Claims Must Contain MBI

# Beginning January 1, 2020, Medicare will reject claims submitted with the HICN.

Providers who use a third party biller, such as a billing service or clearinghouse, may notice that a partial Health Insurance Claim Number (HICN) and the Medicare Beneficiary Identifier (MBI) are appearing on the remittance advice. In this case, it means that although you may have provided the MBI to your billing service/clearinghouse, they are not using the MBI when submitting your claims. Contact your billing service to ensure they use MBIs to submit your claims.

When referring patients for services like laboratory tests, be sure to give the MBI to the entity providing the service. The MBI Lookup tool in Novitasphere can be used to obtain patients' MBIs. Go to the Novitasphere Portal Center to enroll.
