February 8 Council Highlights

Support for MPS Strategic Priorities

Dr. Ashley reported on efforts toward [MPS priorities](#) since the January Council meeting. The first [home page ad](#) from Sheppard Pratt is up, a new source of non-dues income. The Executive Committee met with the financial advisors; no changes are planned. MPS emailed info about the eRx waiver and telehealth survey to engage non-members.

Executive Committee Report

The MPS sent [letter to Baltimore City Commissioner of Health](#) calling for more shelters for covid-positive people. We are taking a proactive role on the future of telehealth coverage by alerting members to the [NORC survey to inform telehealth policy](#), urging those who receive an invitation to participate. Finally, she noted that Aliya Jones, M.D. will step down as Behavioral Health Administration Deputy Secretary on May 24.

Legislative Committee Report

Dr. Hanson said over 1800 bills have been introduced so far, of which the committee has reviewed 52 and taken a position on 20. Priority bills are posted on the [website](#). Prior authorization legislation, introduced by Senator Ready per MPS and WPS request, is out – [SB688](#). The MPS is opposing a bill to allow behavioral health providers licensed out of state to practice via telehealth and a bill to authorize clinical nurse specialists (CNS) to prescribe without limitations or supervision. MedChi opposed the CNS bill but is getting pushback from certain physicians. MPS is alerting members to contact their legislators with concerns about the CNS bill.

Membership and Recruitment Committee Report

Council reviewed the committee's plan for contacting members at risk of being dropped for non-payment of 2022 dues. A list of those who owe MPS and/or APA will be provided at the next meeting.

Nominations and Elections Committee Report

Dr. Hackman reviewed the slate that was approved last year. Cynthia Major Lewis, M.D. has withdrawn from the Council race as she is overextended.

Old Business

Dr. Ehrenreich returned to the concern expressed last meeting about access to acute care. He explained that MPS will meet with BHA the following week and requested ideas to raise. Dr. Hightower suggested we try to encourage more RRP's and housing providers who can accept the patients needing discharge, thereby expanding the number of available beds. Dr. Hansen recommended using specialized halfway houses for conditional release supervision of forensic patients (e.g. Hamilton House). Dr. Triplett shared that the Maryland bed registry is being revived starting tomorrow. A report is to be submitted each morning to Sheppard with the number of available beds. The prior registry did not work out; all beds are not equal, nor are patients. Concerns were

raised as to whether the registry could be used to charge institutions with EMTALA violations. Ideas for possible registry improvements include looking at other state programs, reviewing Maryland crisis services reform work on urgent BH care, and shifting the focus to the patients who are waiting.

Dr. Shaya made a motion that the Executive Committee consider forming a task force of health system representatives, possibly including VA and state hospitals, to address emergency psychiatric service needs and report back within 6 months. Council voted unanimously in favor.

MPS Bills Of Interest

OPPOSE:

[HB1177](#): **Expert Witnesses – LCSW**: Altering a provision of law authorizing a licensed psychologist to testify as an expert witness on certain issues in a court or administrative hearing to also include a certified social worker-clinical licensed under the "Maryland Social Workers Practice Act" and qualified as an expert witness.

[HB982](#): **Health Occs – Faith-Based Counseling – Exemption**: Establishing an exemption from licensure requirements under the Maryland Professional Counselors and Therapists Act for an individual offering faith-based counseling services in coordination with a religious organization; prohibiting an individual who receives an exemption from offering medical care, medical detoxification, or medical withdrawal services; and authorizing the Maryland Department of Health to revoke an exemption under certain circumstances.

[HB 276](#): **Clinical Nurse Specialists – Prescribing Authority**: Defining "clinical nurse specialist" and "practice as a clinical nurse specialist" for the purpose of authorizing clinical nurse specialists to prescribe drugs and durable medical equipment under regulations adopted by the State Board of Nursing; altering the definition of "authorized prescriber" for purposes of the Maryland Pharmacy Act to include clinical nurse specialists; and authorizing a licensed physician to personally prepare and dispense a prescription written by a clinical nurse specialist.

SUPPORT:

[SB688](#): **Utilization Review for Coverage of Prescription Drugs**: Establishing certain requirements on utilization review of prescription drug and device coverage by health insurers, nonprofit health service plans, and health maintenance organizations; providing that a denial of coverage for a prescription drug or device made during the course of utilization review is eligible for an expedited appeal under certain circumstances; etc.

[HB657](#): **Standardized Behavioral Health Screenings – Students**: Requiring the Maryland Consortium on Coordinated Community Supports to develop, in consultation with certain stakeholders, guidelines for developing a standardized behavioral health screening to identify students with behavioral health services needs; requiring that the screening be given to the parent or guardian of each student when the student enrolls for school and every year thereafter; and requiring each behavioral health services coordinator to develop and implement a certain standardized behavioral health screening.

SLRP and MLARP Applications Open

The Maryland Department of Health administers the State Loan Repayment Program (SLRP) and the Maryland Loan Repayment Assistance Program (MLARP). The SLRP provides educational loan repayment funds to physicians who serve a 2 year obligation in a health professional shortage area (HPSA) or medically underserved area (MUA), either in primary care or mental health. The MLARP provides educational loan repayment funds to physicians and medical residents who serve a 2 year obligation in a HPSA or MUA or state designed health professional shortage area. Eligible physicians and PGY4 residents can apply beginning March 1. **The deadline is April 15.** [Click here](#) for more information and requirements.

Negative Balance Recoupment Update

In December 2021, many providers received a *Notice of Recoupment of Retro-Eligibility and Overpayments* letter from Optum and had the opportunity to complete the *Negative Balance and Claim Lifecycle Report Survey*.

During the week of February 7, Optum Maryland placed letters in provider Incedo mailboxes that confirm their survey responses and provide specific information on recoupment. Providers who received the *Notice of Recoupment of Retro-Eligibility and Overpayments* letter, but never responded to the survey, also received this letter.

Maryland CDS Renewal Problems

The Maryland Department of Health network security incident has impacted its systems. MPS members have shared on the listserv that delays have occurred with Maryland CDS renewals. For example, online renewal mid-month was not in time to receive a certificate by expiration at month end.

OCSA has [posted](#) clarification, " All pending renewal applications that were submitted at least 2 weeks before their expiration date are hereby extended until a final determination on the application has been made by OCSA. Any registrant whose registration is due for renewal should submit their renewal application timely, and their existing registration will similarly be extended until OCSA makes a final determination. When the MDH network resumes normal operations, an email notification will be sent to all registrants and a notice will be posted on our website at <https://health.maryland.gov/OCSA>."

The [CDS website](#) specifies that applicants can renew their registration up to 60 days before or 30 days after the expiration date listed on the certificate.

A member reported that when the [link to check application status](#) did not work, a call to (410) 764-2890 and email to Maryland.OCSA@maryland.gov were successful in obtaining a personalized "Temporary Renewal of Controlled Dangerous Substance Registration" letter, which explained that renewal processing was delayed due to the cyber attack and extended the CDS expiration by two months. This letter was helpful when the DEA Diversion Control Division emailed that the state CDS license was past its expiration date, and if this was not corrected, the DEA registration could be terminated. The member used the [DEA website's](#) "make changes to my DEA registration" link to update the CDS expiration date to reflect the date in the Temporary Renewal letter. The local DEA Diversion field office requested a copy of the Temporary CDS Renewal.

Important Reminder! NORC Survey Help Inform Future Telehealth Policy

NORC survey invitations to a randomly selected sample of providers across the State are imminent. The letters invite providers to go to a website and enter a PIN number to take a survey. The survey takes about 30 minutes to complete and is voluntary and confidential. Responses will be used in aggregate only and the information will only be disclosed to researchers at NORC. The survey will be fielded for about eight weeks.

Given the importance of telehealth during the continuing pandemic and beyond, it is critical that psychiatrists and their staff be alert to US Postal Service mail (at the NPI address on file with the [National Plan and Provider Enumeration System](#)), specifically a letter from NORC at the University of Chicago that could include a survey invitation. Recent telehealth expansion has helped limit COVID spread and has also improved access to care for those with challenging social determinants of health, such as rural location and access to transportation and childcare. Audio only coverage accommodates patients who are unable to use or without broadband service and video technology.

If you received a letter, PLEASE RESPOND. The survey will inform recommendations on telehealth audio-visual and audio-only coverage and reimbursement for the 2023 legislative session when the Maryland General Assembly will decide whether to continue [Preserve Telehealth Access Act of 2021](#) provisions covering audio-only telehealth and requiring the same reimbursement for telehealth visits as for in person.

Implicit Bias Training Required for 2022 License Renewal

The Maryland Board of Physicians posted a [notice](#) regarding the [new law](#) that goes into effect on April 1, 2022 requiring all renewing licensees to [complete an implicit bias training program](#) approved by the Cultural and Linguistic Health Care Professional Competency Program. Licensees whose last name begins with A-L and expires 9/30/2022 must complete one course of the program as a condition of license renewal. Those whose last name begins with M-Z and expires 9/30/2023 have another year to complete the course. **This is a one-time requirement.** [Click here](#) for a list of approved training program courses.

MPS Introduces Legislation on Prior Authorization Reform

Prior authorization is a reoccurring complaint we hear from members. While prior authorization is promoted as a savings mechanism, members know that these protocols often keep patients from treatment when they allow insurers and PBMs to impose extensive paperwork requirements, multiple phone calls, and significant wait times for treatments and medications. We are pleased to announce that MPS and WPS introduced [Maryland Senate bill 688](#) to reform prior authorization and ensure patients have timely access to medications.

A group of members from MPS and WPS worked with APA's State Government Relations team over the summer to draft legislation that addresses these particular concerns. This fall, Senator Ready agreed to sponsor the bill and during [this month's hearing](#), (Forward the video to 2:31:26 for bill testimony) he highlighted how SB 688 would not just protect patient access to medications, it would also help to alleviate some of the pandemic burnout clinicians are experiencing. Thank you to Robert Herman, MD, Joseph Collins, MD and Jennifer Dorr, MD, for traveling to Annapolis to offer outstanding and strong in person testimony in support of this bill!

Specifically, SB 688 would:

- Eliminate prior authorization for generic medications that are not controlled substances.
- Eliminate prior authorization for dosage changes of the same medication.
- Eliminate prior authorization for generic and brand drugs after patients have been on these medication for six months without interruption.
- Require insurers and PBMS to adhere to a 48-hour appeal process to ensure timely access to medications for patients.
- Prohibit plans from denying medication on the grounds of therapeutic duplication if the patient has already been subject to review for the same dosage and it was previously approved.
- Require denials and denial reviews be conducted by physicians in the same or similar specialty as the health care provider whose recommended treatment is under review.

MPS worked with MedChi to pass a resolution in support of the language and this has ensured that the broader House of Medicine is in support of the bill. Increasingly, legislators across the country are recognizing how onerous prior authorization is on clinicians and that time spent on burdensome requirements would be better spent on direct patient care.

What's next? We will continue to work to advance the bill this session and look for opportunities to work with legislators on solutions to our patients' most pressing needs. We are hopeful that this partnership between MPS, WPS, APA, and our lobbying team will continue to be a resource to our legislature and that our members will soon be able to see the fruits of our advocacy. We will be calling on MPS members to send letters to your Senators as this bill moves through the legislative process.

APA Raises Concerns to Congress on FDA REMS

On January 27, APA signed onto letters to House and Senate leaders to express concerns about the recent FDA modifications of the Risk Evaluation and Mitigation Strategies (REMS) for clozapine and isotretinoin. The letters explain that changes to these REMS create unnecessary disruptions to patient care and could result in relapse with devastating effects, including hospitalization, suicide attempts, and even violent acts. The letters urge Congress to request that the FDA halt the REMS program changes until a thorough review of the programs is completed to reduce disruptions to treatment. Further, the [House letter](#) and the [Senate letter](#) request hearings to discuss these issues.

APA Action Paper Deadline

The deadline for action papers to be considered at the May 2022 Assembly meeting is **March 24**. An Action Paper is the product of an idea about how the APA can work on behalf of its members. APA Joins Letter to Congress on Telehealth

On January 31, APA [joined a letter](#) to House and Senate leadership on how Congress can best support healthcare providers and patients by continuing and expanding access to telehealth services. Telehealth flexibilities that were created as a response to the current public health emergency have improved patient access to care and have impacted both public health programs and private health coverage, so continuing these services will provide certainty to beneficiaries and providers. The letter asks for the continuation of all telehealth waivers through December 31, 2024, that the Department of Health and Human Services evaluate telehealth and create an aggregate report on their findings for Congress, and to consider permanent telehealth legislation in 2024.

APA Raises Concern on No Surprises Act Burden

APA signed onto a [letter](#) with a coalition of other behavioral health associations, including the American Psychological Association, expressing concern to CMS that the No Surprises Act requirement that patients be provided with a good faith estimate (GFE) adds to providers' administrative burden. The coalition points out that psychiatrists/therapists have a longstanding practice of reviewing costs of care with patients upfront, as required by their professional ethics, and are requesting an exemption. In late January, CMS invited APA and the other signatories to a listening session to gain a better understanding of how the GFE requirements impact the delivery of MH/SUD care. CMS anticipates hosting more sessions with the behavioral health community.

Promoting Positive, Inclusive Conversations

[Well Beings](#) is a public media campaign addressing critical health needs in America. It has created a [Mental Health Language Guide](#) that helps identify the right words for conversations about mental health concerns. It also includes a glossary and a list of other resources. APA Praises Legislation to Address MH Problems and Burnout

APA joined five physician groups in commending passage of the [Dr. Lorna Breen Health Care Provider Protection Act](#) (HR 1667). The legislation establishes grants to prevent and reduce suicide, burnout, and mental and behavioral health conditions among health care professionals. After passing both the House and Senate, the bill now heads to President Biden's desk for signature. According to a [news release](#), the Act will:

- Establish **grants** for health profession schools, academic health centers, hospitals, etc. to help them train health workers in strategies to prevent suicide, burnout, and mental health conditions, including substance use disorders.
- Identify and disseminate **best practices** for reducing and preventing suicide and burnout among health care professionals and training them in strategies to promote mental health.
- Establish a **national campaign** targeting health care professionals to encourage them to seek support and treatment for MH/SUD and stigma associated with seeking care for these conditions.
- Establish **grants** for health care professionals and professional associations for employee education, peer-support programming, and mental health treatment.
- **Study** the impact of the COVID-19 pandemic on the mental health of health care professionals.

The legislation also directs HHS to develop policy recommendations to remove barriers to accessing treatment and identify strategies to promote resilience, according a [congressional summary](#) of the bill.

March Marks Release of DMS-5-TR

This month APA Publishing will release the *Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition, Text Revision (DSM-5-TR)*. Significant changes include the addition of prolonged grief disorder and the inclusion of symptom codes for suicidal behavior and nonsuicidal self-injury, refinement of criteria, and comprehensive literature-based updates to the text. The revised manual includes clarifying modifications to the criteria sets for more than 70 disorders, updates to descriptive text for most disorders based on literature reviews, and a comprehensive review of the impact of racism and discrimination on the diagnosis and manifestations of mental disorders. *Consultation codes: 99241-99245 (outpatient) or 99251-99255 (inpatient)

OR

*New patient/Initial Day E/M codes (for Medicare and several other payers): 99202-99205 (outpatient) or 99221-99223 (inpatient)
