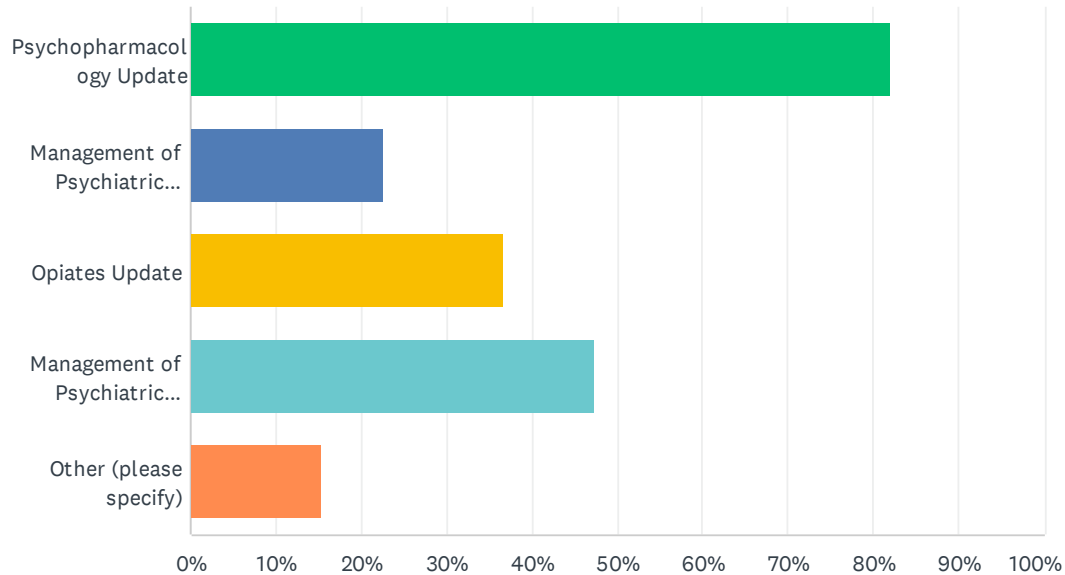

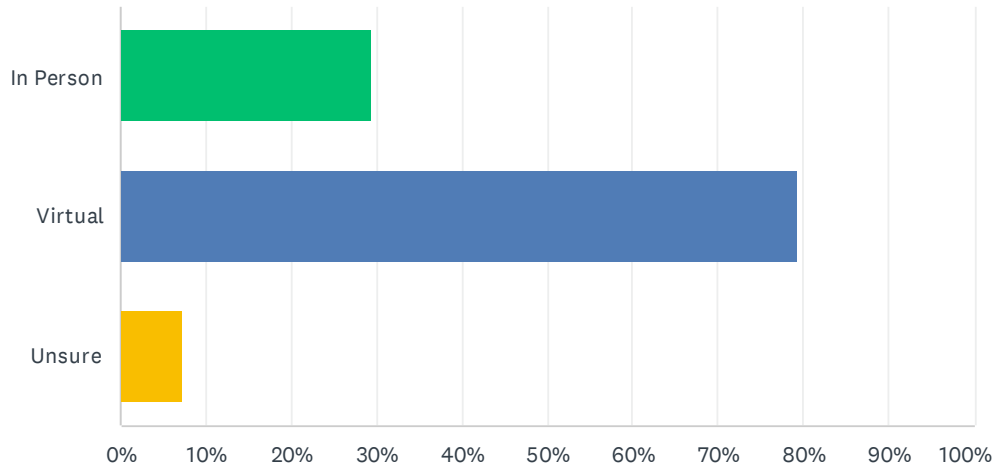

Q3 What Type of CME Meeting Are You Most Likely To Attend?

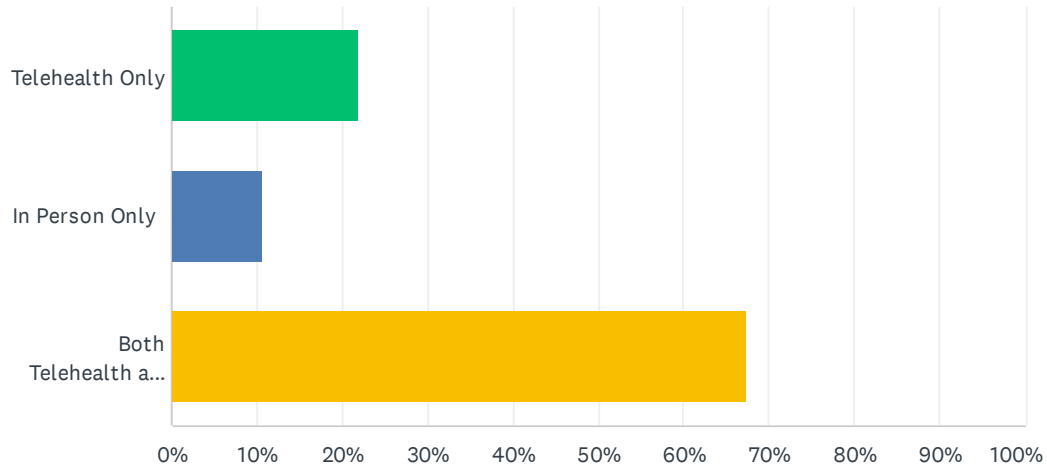

Q4 Are You Currently Seeing Patients Via:

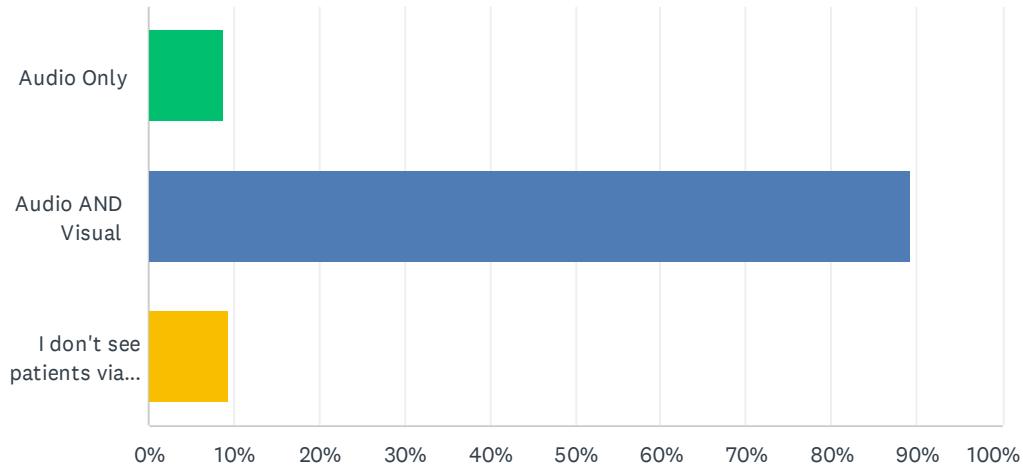

Q5 When Seeing Patients Via Telehealth Which Do You Use? (check all that apply)

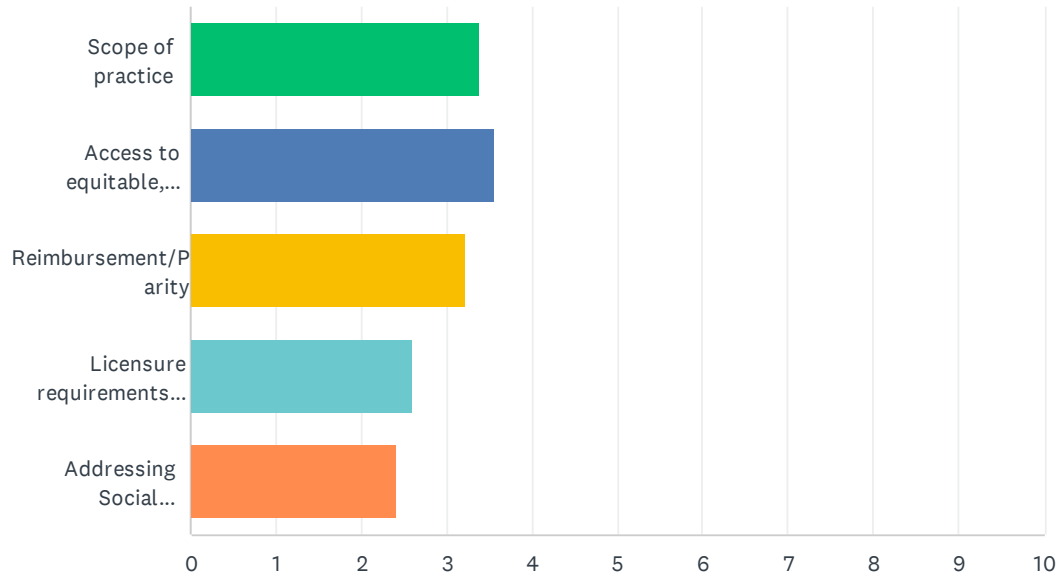

Q6 Please Rank Your Legislative and Advocacy Priorities in Order of Preference: (1=most important)

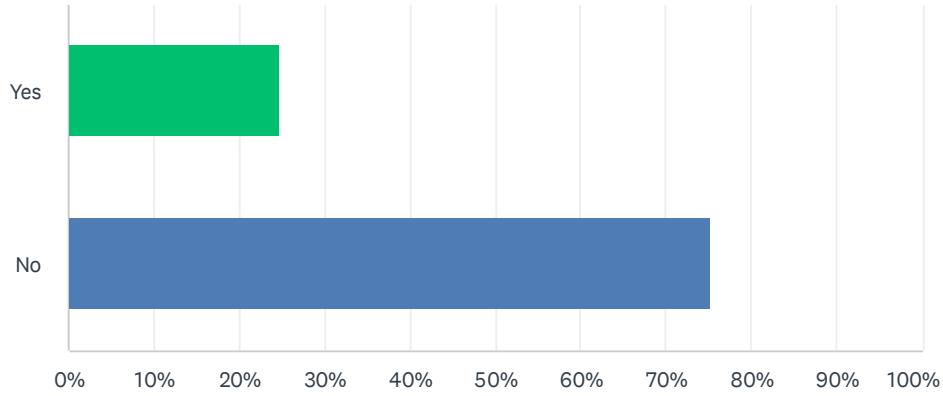

Q7 Do You Have Any Experience in Being a Consultant Using the Collaborative Care Model (CoCM)?

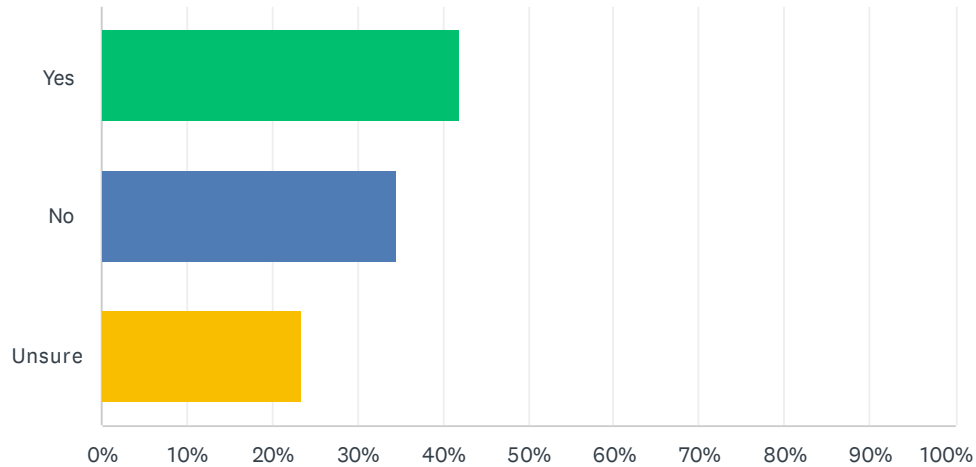

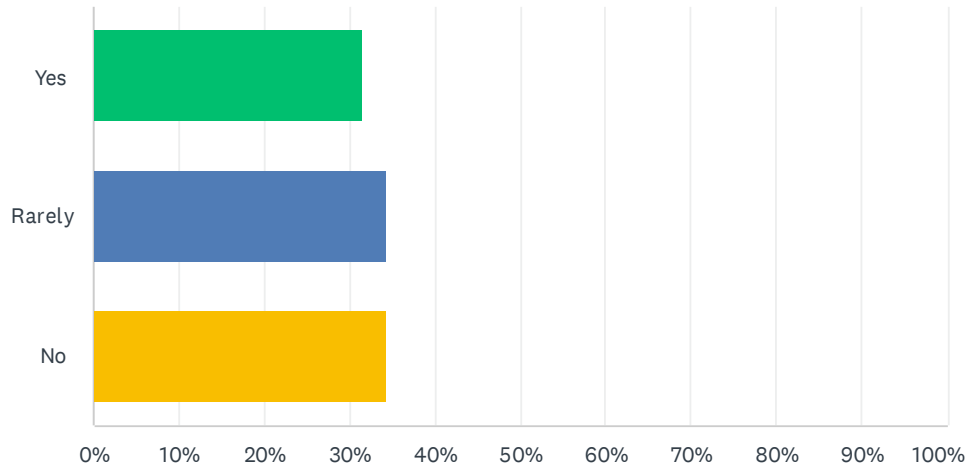

Q10 Do You Participate in Social Media?

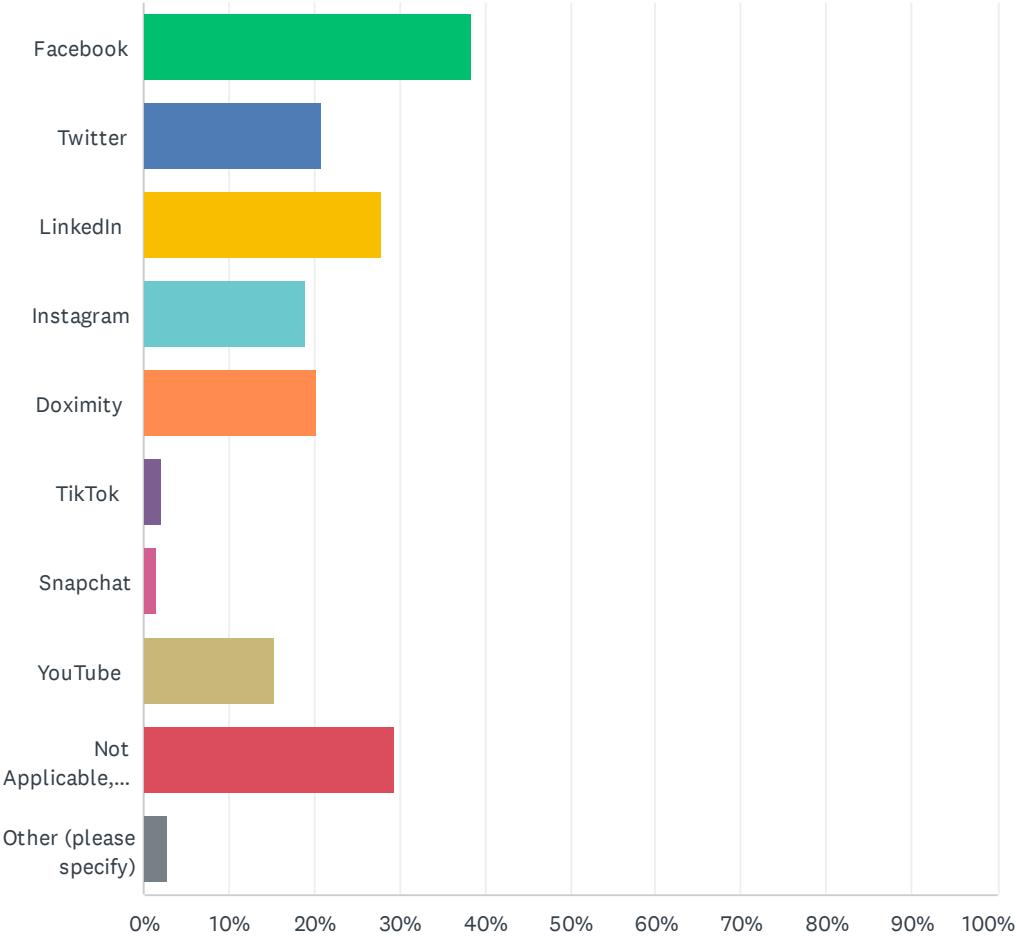

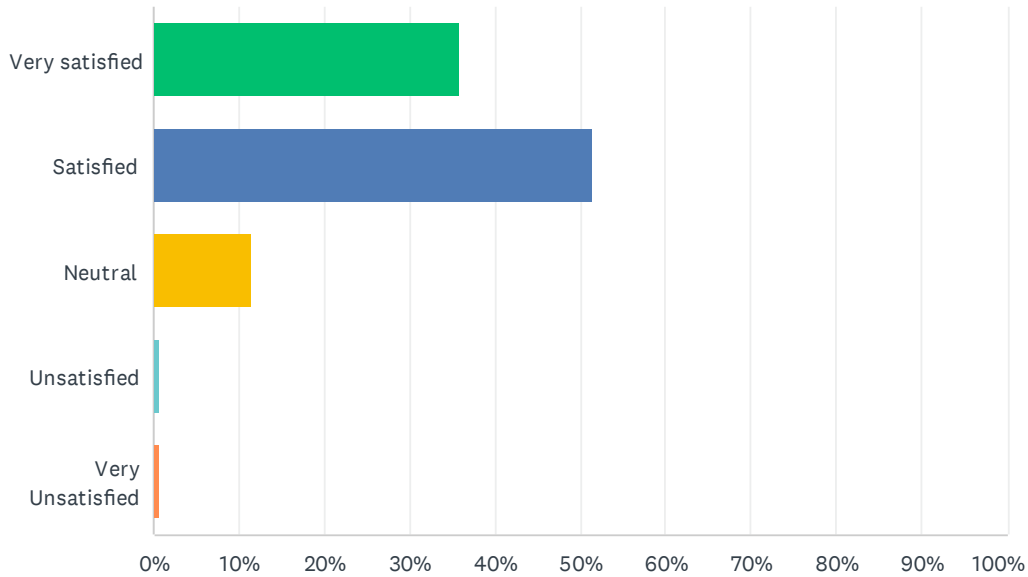

Q12 What Is Your Overall Level Of Satisfaction With The MPS? (Select One)

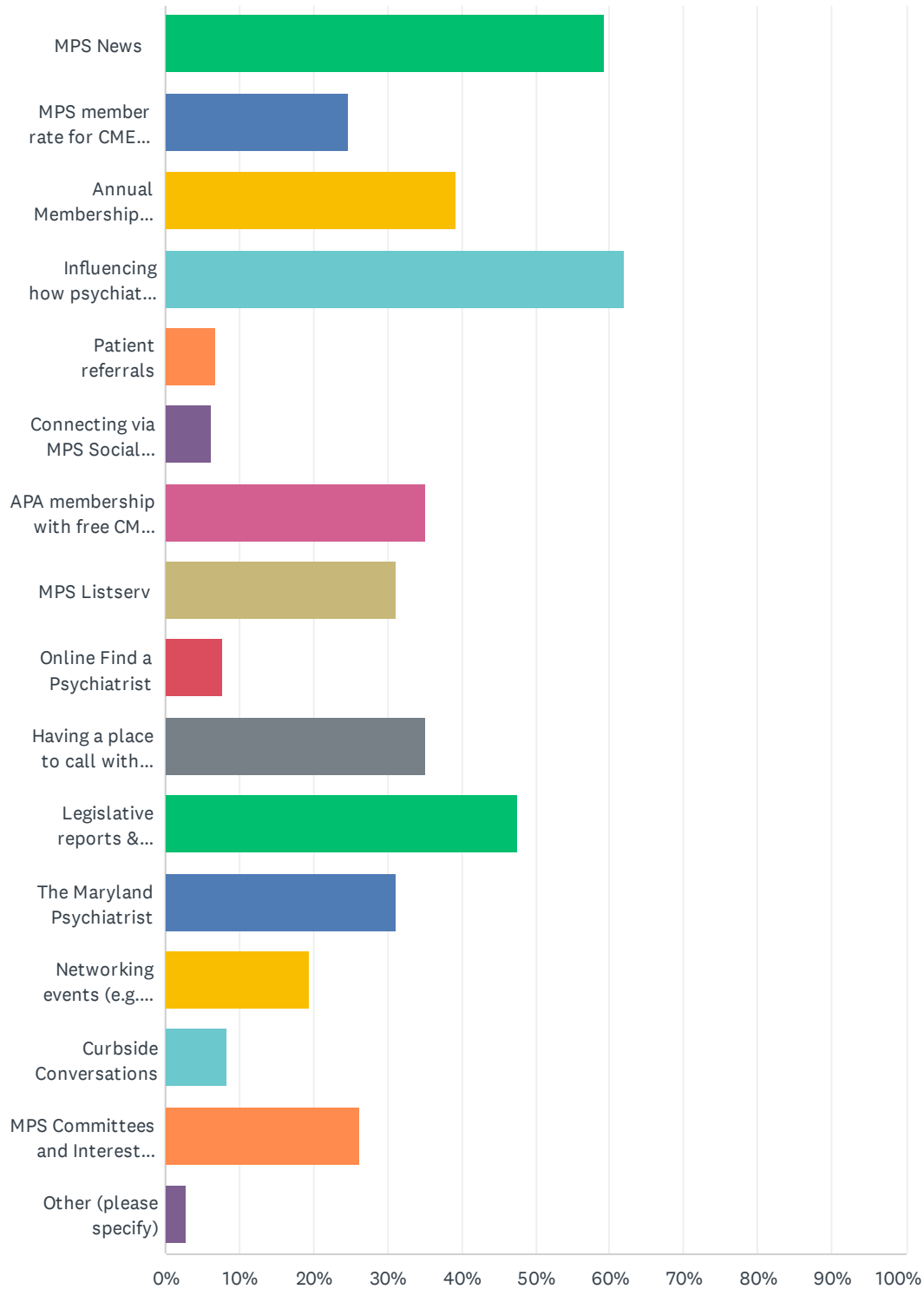

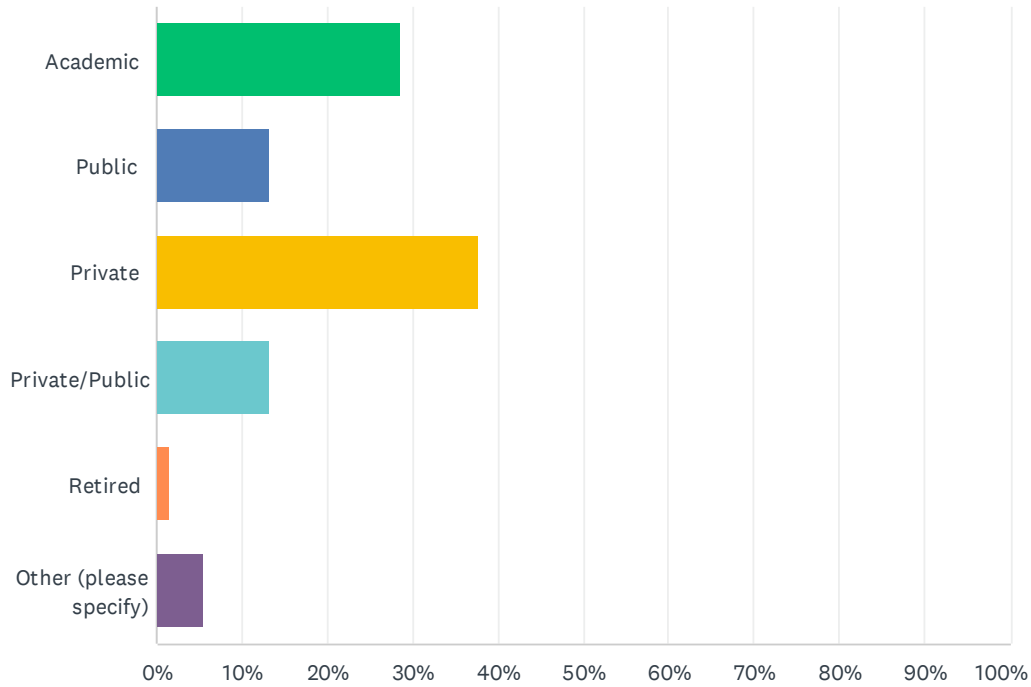

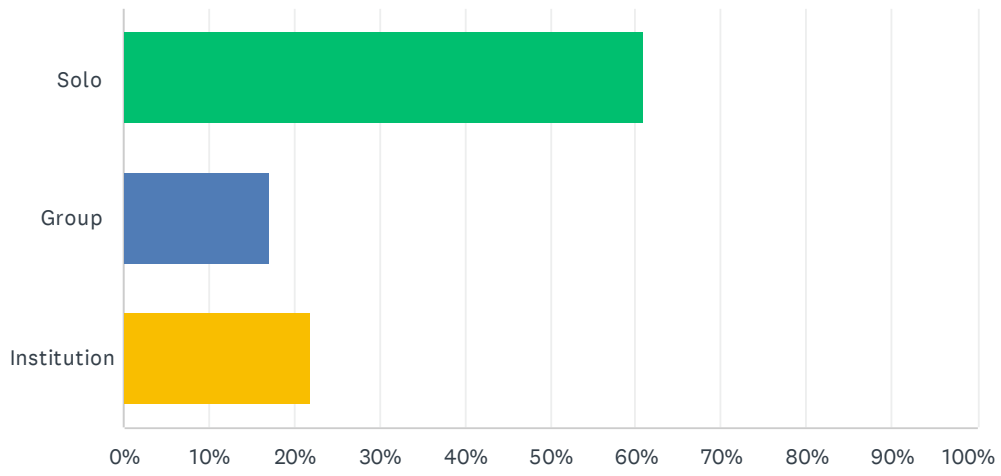

Q17 If You Work In Private Practice, Is It

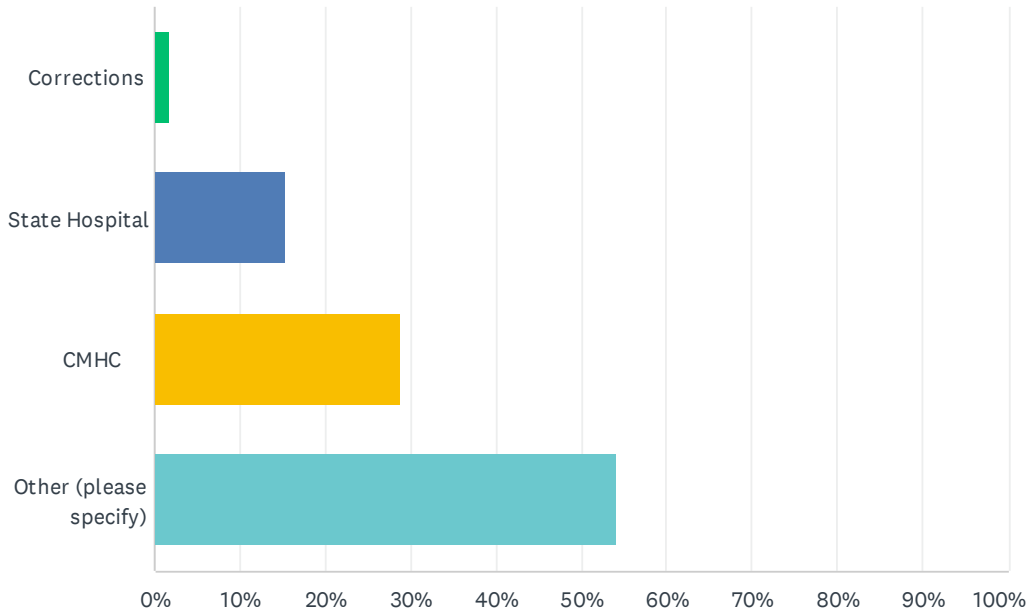

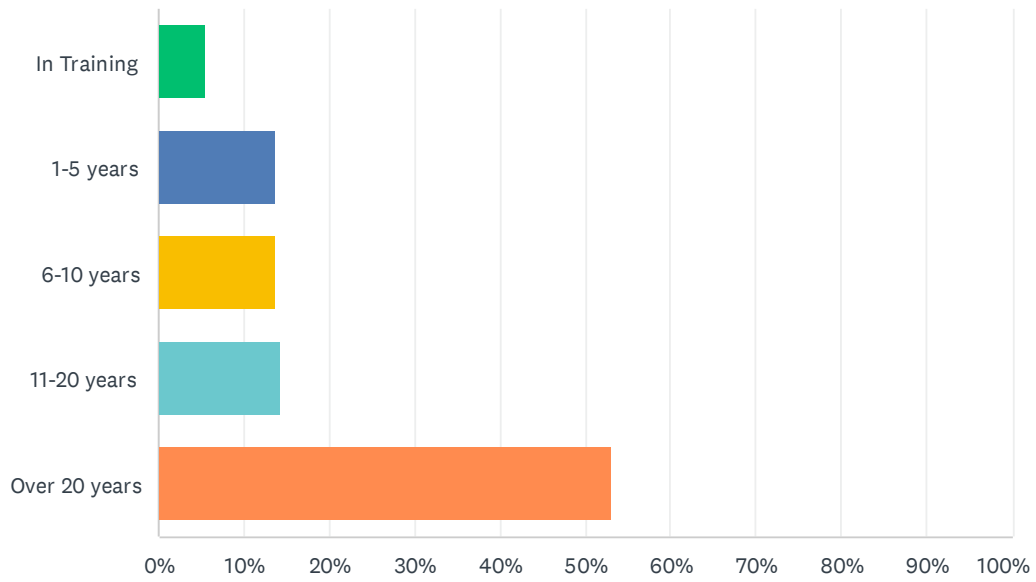

Q19 How Long Have You Been In Practice?

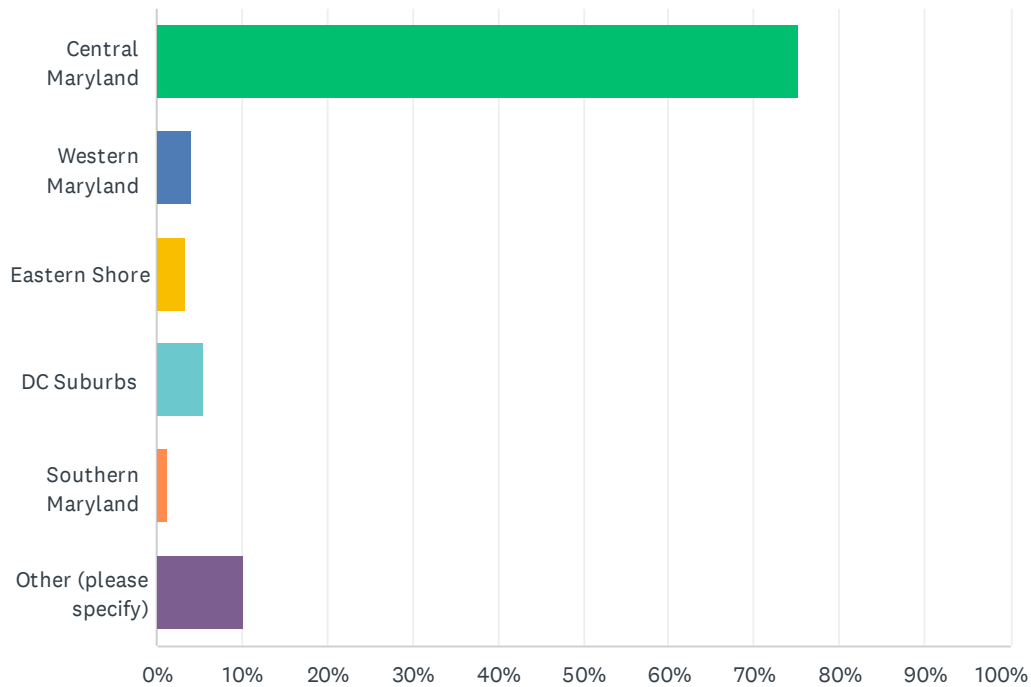
