#### Optum E&M Rates Corrected

An error was identified in the posted <u>Substance Use</u> <u>Disorder Fee Schedule effective July 1, 2024</u>, for dates of service July 1, 2024 – August 31, 2024. When the SUD fee schedule was updated with the 3% rate update for community-based providers for FY25, the 3% update was applied to the E&M rates for PT 50 in error. E&M rates are set by the Maryland Department of Health and changes are announced via transmittal. The error to the posted schedule has been corrected to the impacted E&M rates for PT50.

This updated fee schedule now reflects the correct, reduced E&M rates for dates of service July 1, 2024 – August 31, 2024, for the following service codes: 99202, 99203, 99204, 99205, 99211, 99212, 99213, 99214, and 99215. Claims that were approved and paid at the incorrect rate will be reprocessed. This reprocessing will result in a retraction of the overpayment or could result in a negative balance to providers if there are insufficient claims to offset the reduction.

The Maryland General Assembly will convene at noon on January 11. Several key dates of interest include:

- January 15: Final date for Governor to introduce budget bill and capital budget bill
- February 3: Any Senate bills introduced after this date will be referred to the Senate Rules Committee
- February 7: Any House bills introduced after this date will be referred to the House Rules and Executive Nominations Committee
- March 17: Opposite Chamber Bill Crossover Date Each Chamber must send to other Chamber those bills it intends to pass favorably Opposite Chamber bills received after this date subject to referral to Rules Committees
- March 31: Budget bill to be passed by both Chambers
- April 7: Adjournment "Sine Die"

#### Maryland Extends Pause on New Addiction and Mental Health Licenses

The Maryland Department of Health announced at the end of December the pause on new licenses for certain types of addiction and mental health providers will continue for another six months as the state continues to investigate suspected Medicaid fraud, waste and abuse. The moratorium, <u>first announced in June</u> was originally set to expire at the end of 2024. The affected licenses are for psychiatric rehabilitation, partial hospitalization and intensive outpatient programs.

In December of 2024, a news article revealed that state officials failed to vet and audit addiction treatment operators properly, allowing for a flood of new programs, some of which used tactics officials described as unscrupulous and illegal. The investigation looked into PHA Healthcare, a government-funded addiction treatment program that provided little help to its patients and put them in free housing where many relapsed and overdosed.

Halting the issuance of new licenses is one step the state is taking to try to address problems in the field. The health department said in a December news release that it is also rewriting regulations, moving to a new vendor to process Medicaid payments, analyzing services which may be underutilized and exploring new services with lower costs.

# Free PCSS-MOUD Half & Half MOUD Training

On Friday, January 10th, MACS for MOMS is hosting a PCSS-MOUD Half & Half Training. This course provides an overview of the FDA-approved medication buprenorphine prescribed for the treatment of opioid use disorder (OUD). The course trainer will conduct an overview of prevention, identification, and treatment of SUDs emphasizing OUD.

The 8-hour buprenorphine training is offered in a 'half and half' format: 4 hours of in-person training from 8AMto 12:15PM on January 10 followed by 4 hours of online training through the PCSS-MOUD portal that must be completed within 30 days of this course. Completion of both components of this training fulfils the 8-hour substance use training required for DEA registrants and renewals as mandated in the MATE Act. #### Gender and Racial Wage Gaps Persist for Maryland's Physicians

MedChi's latest physician salary survey indicates that pay gaps persist between male and female physicians in Maryland. Conducted by Berkeley Research Group's Healthcare Transactions & Strategy practice, on behalf of MedChi, the survey tracks compensation, benefits, and practice metrics of Maryland physicians with a new emphasis on measuring transparency in compensation structures. It benchmarks compensation among Maryland physicians by gender, age, ethnicity and practice status, and also examines how Maryland physicians' compensation has changed since the pandemic.

Despite overall improvements in compensation since 2021, racial and gender disparities still exist in salaries for Maryland physicians who identify as Black/African American. Gender-based compensation disparities between Maryland physicians have not changed much since 2020, when males earned 50% more than females. Today, males surveyed report earning 45% more than females on average.

MedChi's Gender Pay Equity Committee identified compensation transparency as a key element of pay equity and recommended that this year's survey include questions that aimed to measure the impact. Transparency within an organization can help close gender- or race-related gaps in compensation while potentially improving employee sentiment around whether their compensation is fair and reasonable. Maryland physicians at practices with compensation transparency, particularly during the hiring process, are more often paid higher salaries.

#### CLIMATE CORNER

I hope you had a peaceful end to 2024! 2025 ushers in a new legislative season at the Maryland General Assembly (1/8 to 4/7) and thus a new opportunity to make a difference at the state level. MPS will keep you updated about legislation explicitly related to mental health in Maryland. In this column, I will keep you updated about climate and environmental legislation that can have public mental health benefits.

Two bills that I highlighted in March's <u>column</u> did not pass last year, but they stand a very good chance of passing this year. If you agree that they are important, you can help ensure their passage by emailing or calling your legislators now to elicit their support. Your voice truly matters. To find contact information for your representatives, go to <a href="https://mgaleg.maryland.gov/mgawebsite/members/district">https://mgaleg.maryland.gov/mgawebsite/members/district</a> and click "Lookup" to enter your address. I have provided a script for two bills below. When you message a representative in the House, reference the House Bill (HB) number. When messaging your Senator, reference the Senate Bill (SB) number.

Reclaim Renewable Energy Act: Dear Senator/
Representative: As a psychiatrist in your district, I support
The Reclaim Renewable Energy Act SB0010/HB0220.
Currently, trash incineration is eligible for the same state
subsidies as wind and solar under the Renewable Energy
Portfolio Standards (RPS), even though it produces more
greenhouse gas emissions relative to other power sources
and emits toxic air pollutants. Research shows that air
pollution is associated with slower cognitive processing
speed and more externalizing behaviors in prenatallyexposed children as well as a higher incidence of dementia
in adults. Passing this bill will safeguard the brain health of
our children and seniors by shifting tens of millions of
dollars in state subsidies from incineration companies to
truly clean energy sources like wind or solar.

Maryland Beverage Container Recycling Refund and Litter Reduction Program (AKA the Bottle Bill): Dear Senator/ Representative: As a psychiatrist and constituent in your district, I support the Bottle Bill (SB# pending, HB0232), which instates a beverage container reuse and recycling program that does not cost the State any money and that saves money for local municipalities through reducing litter and landfill. This reduction also has important environmental health benefits. Plastics pollution has been identified as a potential threat to our collective brain health. By reducing plastic bottle litter, we can reduce the amount of microplastics and related chemicals that end up in our waterways

#### **APA News & Information**

#### December APA Board of Trustees Meeting Highlights

The information below constitutes unofficial highlights of the meeting prepared by the Administration and is subject to change.

Report of the CEO and Medical Director: Dr. Marketa Wills, MD shared her written report highlighting the Administration's work for the past quarter (the report can be found here). In the update on the 2024 Board-approved strategic priorities, Dr. Wills emphasized two key areas where the Administration is making strong progress. The first is fostering a culture of trust, transparency, and cooperation within governance, the Assembly, APA Components, the membership, and staff, to strengthen the organization and the second focuses on enhancing sustainability through improved execution, budget and operational discipline, increased annual meeting sponsorships, and an internal policy library. Dr. Wills presented a new strategic reserve policy for approval that introduces two reserve funds. She concluded her report by sharing a timeline for the development of the strategic plan with an anticipated proposed draft for review and approval to the Board in December 2025.

**Report of the Treasurer:** Dr. Steve Koh, MD Treasurer, provided a financial report as of October 31, 2024. Three of the five key financial metrics met expectations for the year. The exception is that the total forecasted revenue of \$54.8M is \$1.2M below the full year budget of \$56M. This reflects the below-budget revenue for the annual meeting, which resulted in a shortfall of \$2.7M in revenue mainly due to lower sponsorship and exhibit sales.

**2025 Budgets**: The Board considered the 2025 budget in light of APA's experiences over the past two years and losses resulting from our Annual Meeting and the Mental Health Services Conference. The Board approved a 2025 APA budget that prioritizes supporting members and programming, while limiting expenditures on APA-sponsored in-person meetings through increased use of virtual solutions.

To that end, the Board will hold half of its meetings virtually and reduce the cost of the two in-person meetings significantly. In addition, the Assembly Executive Committee and Area Councils will meet virtually, and the cost of the November Assembly meeting will be substantially reduced. The Joint Reference Committee, Councils, and District Branch Executives will also meet virtually. While the Board recognized the benefits of in-person meetings, it also acknowledged that during the pandemic, the organization managed to conduct all its business virtually. The Board approved the 2025 budget with the proposed strategic initiatives and capital expenditures.

**Mental Health Services Conference Transition:** For more than a decade, APA has sustained substantial out-of-pocket

losses at the Mental Health Services Conference, in which a limited number of APA's members participate. Recognizing the immense value of our community psychiatrists and the dire need for the important work that they do, APA will continue to support education and fellowship among community psychiatrists and engage others in that work by transitioning the 2025 Mental Health Services Conference to a robust community psychiatry track at the 2025 Annual Meeting in Los Angeles.

**Early Career Psychiatrist Work Group Update:** Tanuja Gandhi, MD, FAPA, Chair of the Membership Committee and Eary Career Psychiatrist (ECP) Work Group, presented a highlevel review of strategic recommendations based on the three-pronged approach to improve ECP engagement. The prioritization and implementation phase of the initiative is slated to begin early 2025.

#### APA 2024 Federal Advocacy Wins

In 2024 APA has worked closely with Congress, the White House, and Federal agencies to ensure access to care for persons with mental illness. Before leaving for their December recess congressional leaders proposed a healthcare package in addition to a resolution to keep the government open. While APA hoped for a much-needed end -of-the-year healthcare package, Congress did not bring it to the floor for a vote and instead passed a very limited short-term continuing resolution to keep Federal agencies operating with just a few other extensions. One of these extensions was the Medicare telehealth flexibilities that included delaying the 6-month in-person requirement until March 31.

Although Congress did not advance much healthcare legislation this year, APA noted some key regulatory advocacy successes in 2024 including:

- Equal pay for tele health and in person care: Care provided via telehealth will now be reimbursed by Medicare at the same rate as in-person care using existing evaluation and management codes for outpatient care.
- Prescribing Controlled Substances via telehealth: The
  Drug Enforcement Administration and U.S. Department
  of Health and Human Services issued a third extension of
  COVID-19 telehealth flexibilities for the prescribing of
  controlled substances, to be effective through December
  31, 2025.
- Supervision via telehealth: The Centers for Medicare & Medicaid Services extended for another year the ability for residency training programs to supervise residents virtually when all parties are virtual.
- Removal of Barriers to Clozapine: The re-evaluation of the Clozapine REMS program, concluding in a vote of the FDA's advisory committees, to effectively remove barriers to access the highly effective medication.
- <u>Closing MHPAEA Loopholes</u>: The Department of Labor released its final rule, strengthening enforcement of the 2008 Mental Health Parity and Addiction Equity Act by requiring insurers to provide data illustrating that their beneficiaries have access to mental health services.

## Medicare Updates

#### Check Your MIPS Eligibility

Your eligibility status may have changed, so please use the <a href="QPP Participation Status Tool">QPP Participation Status Tool</a> to confirm your final 2024 Merit-based Incentive Payment System

(MIPS) **eligibility.** The look up tool also identifies clinicians who qualify for reweighting under the automatic Extreme and Uncontrollable Circumstances policy, as outlined in the 2024 MIPS Automatic EUC Policy Fact Sheet.

The tool also includes the initial 2025 eligibility status for MIPS based on these thresholds:

- 1. Bill more than \$90,000 a year in allowable charges for covered professional services under Medicare; **AND**
- 2. Furnish covered professional services to more than 200 Medicare Part B beneficiaries; **AND**
- 3. Provide more than 200 covered professional services.

#### 2024 MIPS Data Submissions

The CMS data submission period for 2024 Merit-based Incentive Payment System (MIPS) eligible clinicians begins January 2. Data can be submitted and updated through 8:00 PM on April 1. Note: Clinicians who are unsure about their eligibility to participate in MIPS for 2024 can check their final status using the QPP Participation Status Tool. Clinicians and groups that are opt-in eligible will need to make an election to opt-in or voluntarily report before they can submit data. (No election is required for those who don't want to participate in MIPS.)

To Submit 2024 MIPS Data:

- Go to the Quality Payment Program sign in page.
- Sign in using your QPP access credentials.
- Submit your 2024 MIPS data or review the data reported on your behalf by a third party. (You can't correct errors after April 1, so be sure the data submitted is accurate.)

Submission resources will be posted to the Resource Library in January.

#### Physician Fee Schedule Final Rule Summary

For Behavioral Health Services For CY 2025, CMS is <u>finalizing</u> <u>actions</u> to support access to behavioral health, in line with their Behavioral Health Strategy:

- Separate coding and payment under the PFS describing safety planning interventions for patients in crisis, such as those with suicidal ideation or at risk of suicide or overdose, including:
  - \*HCPCS code G0560, for safety planning interventions performed by the billing provider in a variety of settings, billed in 20-minute increments
  - \*Monthly billing code, HCPCS code G0544, when you use specific protocols to provide postdischarge follow-up contact with a patient discharged from the emergency department for a crisis encounter, billed as a bundled service describing 4 calls in a month
- 3 new HCPCS codes (G0552, G0553, and G0554) for approved digital mental health treatment devices provided incident to professional behavioral health services used with ongoing behavioral health treatment under a plan of care.
- 6 new HCPCS codes (G0546–G0551) for interprofessional consultation by practitioners in specialties that mirror current interprofessional consultation CPT codes used by practitioners who are eligible to bill E/M visits.

## Medicare Updates

#### Qualified Clinical Data Registries

Qualified Clinical Data Registries (QCDR) and Qualified Registries Qualified Postings approved for 2025 are now available in the Quality Payment Program (QPP) Resource Library. The qualified postings assist clinicians with selecting a QCDR or Qualified Registry that will collect and report clinical data to the Merit-based Incentive Payment System (MIPS) program on their behalf. The qualified postings provide the names of approved QCDRs and Qualified Registries, including the applicable QCDR measures and MIPS quality measures, Promoting Interoperability measures and objectives, improvement activities and MIPS Value Pathways (MVPs) that they are approved to support.

#### AMA Issues Statement Regarding Medicare Cuts

At the end of December, Congress adjourned, leaving in place a 2.83 percent cut for doctors. It did not provide a rational permanent, inflation-based update as the Medicare Payment Advisory Commission recommended. With this new cut going into effect next year, Medicare payment rates have fallen by 33 percent over the past two decades, when adjusted for the costs of running a practice, leaving physicians struggling to figure out how they can continue to provide needed care to their elderly and chronically ill patients.

Congress also inexplicably missed an opportunity to improve patient care by refusing to include prior authorization reform in the final package – a reform with vast bipartisan support in both chambers. Leaving it on the cutting room floor is an unnecessary gift to the insurance industry at the expense of our patients. Physicians have unique training and expertise when prescribing appropriate care, and don't need insurance companies to delay and interfere with patients' vital treatments.

With another cut almost certain to take effect, Congress must enact meaningful long-term reforms. The American Medical Association has put forward many <u>substantive</u> <u>solutions</u> and is eager to work with the new Congress and administration.
