President's Column

Reflections on the Year: Advocacy, Resilience, and Progress for Maryland Psychiatrists

I am deeply grateful for the opportunity to serve as President of the MPS over the past year and am proud of the continued advocacy we've shown for the well-being of our patients, community, and psychiatrists in Maryland. This year has been exceptionally challenging and unprecedented, not only for our country but also for psychiatrists in Maryland and the patients we serve. The events that have unfolded are almost too numerous to count, and the situation continues to evolve daily. The contentious 2024 presidential election has highlighted the deep polarization in our society, and critical issues such as racism, diversity, equity, and inclusion, as well as science itself, have come under attack. Some of our members have expressed strong emotions about these changes, and it has been crucial for us to find ways to support our diverse membership during this difficult

Federal changes are significantly impacting psychiatry, but the MPS has remained committed to defending the values of medicine, fairness, and patient care. Many of our colleagues and patients have voiced concerns about job security, benefits, the growing anti-science movement, sudden deportations, censorship, and other uncertainties. We have stayed informed through our listserv, email from MPS staff, and our monthly newsletter, and we have been active advocates in both the Maryland legislature and other political leaders.

We've built strong connections with state health leaders, meeting several times with Dr. Herrera Scott, and we welcomed Dr. Rachel Talley in her role as the new Chief

Medical Officer for the Behavioral Health Administration (BHA). We have met with BHA officials and sent a letter to the Secretary of Health, Deputy Secretary, Governor, and Lt. Governor expressing concerns about recent funding cuts to psychiatric research and residency programs to protect the vital resources necessary to advance psychiatric care and train future psychiatrists. We've also been committed to advocating for a thorough investigation into the serious safety issues at Clifton T. Perkins. We continue to monitor the situation and have communicated our concerns to BHA, calling for transparency when the final report is released.

Another major focus during my Presidency this year has been to increase our community presence. In addition to our meetings with state health leaders, we have also partnered with the Baltimore City Medical Society to participate in educational and social events and have invited other mental health and medical professionals to our CME events, further establishing MPS as a leader in psychiatry across Maryland.

The goal of joining other organizations is to have a bigger voice in our support of various initiatives. Our joint advocacy includes the Affordable Housing Support Letter with Health Care for the Homeless, the removal of the Fail First requirement with NAMI Maryland, and efforts to stop the de-funding of SAMHSA. Additionally, we have endorsed the Mental Health Parity and Addiction Equity Act (MHPAEA) in Medicaid and CHIP with CMS, supported funding requests for gun violence prevention research, and advocated for more rigorous enforcement of MHPAEA within Maryland's Medicaid program.

We have also worked to create more opportunities for member engagement and participation. We conducted our Annual Survey to better understand the needs and priorities of our members. The survey revealed that MPS News, the Listserv, CME activities, and legislative advocacy are highly valued. In February, we held our first General Membership and Council Meeting, offering a unique opportunity for members to share their suggestions and concerns while learning how each committee plays a vital role in advancing MPS's goals. We also launched a new Environmental Mental Health Interest Group focused on climate change and its impact on mental health. The MPS has also fostered connections through the creation of a WhatsApp group for Early-Career Psychiatrists (ECPs). Furthermore, we continue to demonstrate our values by offering several prestigious awards, such as the Ikwunga Wonodi Award, the MPS ECP Fellowship Award, and the Best Paper and Best Poster Awards from the Academic Psychiatry Committee. We are also excited to host our first membership family picnic this summer.

Recruiting recent graduates has remained a top priority. We personally visited residency programs, hosted lunch meetings, and introduced ourselves and our work to trainees. Our events for residents and ECPs have been highly successful, including an RFM Trivia Night with approximately 45 attendees. We've also provided information on APA Fellowships, nominated two residents for the Area 3 RFM award, and organized a Career & Practice Fair.

We've highlighted the relevance and importance of MPS and its committees, and I am deeply grateful for the many accomplishments the committees achieved. The Membership Committee, led by Drs. Akinsanya and Means, has worked tirelessly to increase our membership, with a focus on reaching out to ECPs and trainees. Although we've experienced a higher number of drop-offs in the past three years, we continue to engage with existing and new members and seek input from our membership about additional priorities for our organization. The Community and Diversity Coalition, which is led by Dr. Hackman and me, has been actively organizing educational events, such as discussions on Climate Psychiatry with Dr. Elizabeth Ryznar and "The Color of Wellness" with Dr. Farha Abbasi. We reviewed applications and selected the first recipient of the Ikwunga Wonodi award who will be given the award at the Annual Dinner, and we are organizing a CME event on climate change and community mental health in June. We are also expanding our website resources to support individuals affected by recent federal changes. The Legislative Action Committee, led by Drs. Young and Major Lewis, has done an exceptional job reviewing bills, preparing position statements, and organizing MPS Advocacy Day. Staying abreast of legislative proposals and thoroughly analyzing them is a herculean task. The Academic Committee, under Drs. Peters and Speed, has reviewed submissions for the MPS paper and poster contests, while

the Ethics Committee, led by Drs. Brandt and Means, collaborated with the CME Committee to offer an excellent CME event on the Maryland Physician Health Program. Our CME Committee also organized a successful pharmacology conference with notable speakers like Drs. Neubauer, Welsh, and Yaden. The Distinguished Fellowship Committee, led by Dr. Swartz has made significant strides in nominating more distinguished fellows this year than in recent years. Many thanks to Bruce Hershfield, editor of *The Maryland Psychiatrist*, for producing an outstanding publication and for collaborating with the CME Committee to host an event with Dr. Glenn Triesman. Finally, Dr. DeLucia has successfully expanded the Subspecialty Committee, making it a vital platform for exploring subspecialty needs and goals.

The financial health of MPS remains strong. We've successfully hosted a variety of events and CME programs, and our move to the MedChi building has allowed for greater collaboration with other medical organizations. This move has also contributed to our ability to operate in the black this year, which has been key in providing bonuses to staff and furthering our mission.

I would like to express my deepest gratitude to Meagan Floyd, our Executive Director, Jora Hritz, our Membership Meetings and Publications Coordinator, and Heidi Bunes.. Their dedication to our organization, from managing wonderful newsletters to facilitating smooth meetings and events, to closely following and organizing responses to legislative opportunities has been invaluable. This year, I have more clearly seen the tremendous work they do. I am also incredibly grateful to the Executive Committee—Drs. Carol Vidal, Ronald Means, and Tyler Hightower—for their wisdom and commitment throughout the year. Finally, I'd like to extend a heartfelt thank you to the Council and Committee Chairs for their exceptional leadership, and to the hardworking and creative Committee Members.

As I conclude my year as President, I am honored to be part of a long tradition of individuals who have passionately advocated for high-quality care for our patients, upheld the core values of our medical society, sought out diverse perspectives, and championed scientific integrity, medical ethics, and the psychiatric profession. In the face of societal, political, and financial changes, it is more crucial than ever for us, as psychiatrists and physicians, to defend the core values that define our profession. We can educate others about evidence-based mental health care, speak out in public forums, and support each other by sharing resources. Additionally, we must insist that our leaders in the APA and AMA prioritize the needs of our patients and the values of our profession. To quote RBG, "When injustice becomes law, resistance becomes duty." Let's continue fighting for what we believe in.

March 11th MPS Council Highlights

Consent Agenda

Dr. Vidal noted the Council Minutes for the February meeting, the CME Committee report and the Executive Director's Report were included in the consent agenda. After a few moments of review, Dr. Vidal asked if there were any concerns or comments. Hearing none, the consent agenda was approved unanimously.

Support for Strategic Priorities

Dr. Vidal provided an update on activities that support MPS Strategic Priorities. She reported that since February MPS has:

- Focused on retention efforts for members who still owe MPS and/or APA dues
- Emailed March *MPS News* to recruits asking that they join as members or donate to advocacy
- Sent an Action Alert on important legislation to all nonmembers with donation link
- Secured supporters to help fund the MPS annual meeting (total \$5000.00 so far)
- Moved MPS reserves to higher yielding accounts with financial investment company (\$70k)

Executive Committee Report

Dr. Balis presented the Executive Committee report. Regarding member support, she reported that the MPS staff is beginning to look for options for a family friendly member event to be held this coming Summer. Planning for the 2025 Annual Meeting and dinner is well underway with multiple vendors secured and ticket sales are going well. The MPS Ethics Committee held a successful CME event which generated revenue for the MPS and the CPD Committee is in the early planning stages of hosting a virtual talk on Climate Change in Medicine.

She next reviewed MPS efforts to unify the voice of psychiatry in Maryland, including: Maintaining a continued presence on weekly calls with the Behavioral Health Coalition, Children's Behavioral Health Coalitions, and the Parity Coalition, enhanced communication with NAMI and BCMS around meetings, legislative priorities, and events and continuing to observe MedChi legislative priorities, which are often in line with the MPS and inviting MedChi leadership to an upcoming EC meeting.

Dr. Balis next identified MPS work within promoting leadership opportunities & member recognition. The MPS Executive Committee identified the recipient of the 2025 Presidential Award of Excellence as Paul Nestadt, MD and announced the first recipient of the Wonodi Award, Dr. Brandon Newsome. Committee Chair appointments for 2025-26 are almost completed and the 2025 MPS election has begun, and the deadline to submit ballots is March 31st. The MPS recognized winners of the 2024 Best Paper and Poster Contests and continued to publish member spotlights, shoutouts (new) and publication announcements in MPS News. She concluded by reporting that the MPS

Distinguished Fellowship Committee will meet in March to begin the nomination process for 2025.

Secretary/Treasurer Report

Dr. Hightower presented the 2024 year-end financial statements and form 990 for Council review. She began by remining Council that the financial statements were reviewed, not audited, by Norman Feldman, CPA, PA.

Statement of Financial Position

- Total assets are \$539K, \$15K lower than last year. The difference is because of \$10K less cash, \$13K less accounts receivable and \$5K less prepaid expenses, which are somewhat offset by \$11K more investment reserves.
- Liabilities total \$158K, 16k lower than 2023, which mainly reflects \$11K less prepaid dues and \$10K less prepaid fees.
- Net assets (or equity) of \$381K are the same as last year and include \$2600 that are temporarily restricted for legal advocacy and the Wonodi fund.

Statement of Activity compared to 2023

- Total Support and Revenue of \$346K is down \$114K from 2023, mainly because of the 2023 condo sale.
- Total expenses of \$345K are down \$2K.
- The change in net assets is a \$757 surplus, down from \$112K in 2023, when the office was sold. Interest and investment income contributed positively both years.

Statements of Cash Flows

 Operations during 2024 resulted in a \$5700 decrease in cash, mainly due to less prepaid membership dues and fees.

In-House Statement of Activities vs. Budget

- Total income of \$346K is \$21K over budget. Dues income was \$9500 over budget, despite 25 member drops in the spring.
- Total expenses are \$345K, \$500 under budget.
- The \$757 surplus is \$21K better than the \$20K deficit that was budgeted.

Form 990

- The 990 includes amounts from the financial statements, but with different categories, as well as governance questions, policies, leadership, lobbying expenses, a description of program and services (separate document), and other information.
- The 990-T (p.30 of the PDF) shows \$23K of "unrelated" taxable ad income and \$4,789 federal taxes.
- Per MPS policy, Council will reviewed form 990 and suggest changes needed before it is filed with IRS.

The MPS is very well positioned going forward. The staff transition continued in 2024 and early 2025. Member


retention as well as advertising and other vendor funding are priorities for continued financial success. After a brief discussion, the motion to approve the Secretary Treasurer's report passed unanimously.

Legislative Committee Report

Drs. Young and Lewis present a brief update on the work done thus far by the MPS Legislative Committee. Dr. Young reported that several Committee members provided oral testimony in support of SB509/HB592: Prohibited Possession of Firearms - Assisted Outpatient Treatment Respondents, the bill that MPS drafted. The bill passed the second reading in the House and has crossed to Senate with little to no debate. The Committee continues to meet weekly or as needed and so far has reviewed over 135 bills and taken a position on 39.

Membership Committee Report

Ms. Floyd presented the Membership Committee report. She asked Council to review the drop roster and encouraged attendees to contact any colleagues they know and ask them to pay their outstanding dues; both MPS and APA. Members who have not paid MPS/APA dues or enroll in a payment plan will be dropped from membership on March 31st. Drop letters were sent via USPS to those on the list, and invoices are being sent weekly. The Membership Committee is diligently working to contact members - the list is high, around 125 members – and processing that number of drops would have dire consequences to the MPS bottom line. A Google doc will be shared with Council, which will contain real time updates, and notes regarding the drop list. Next, Council reviewed two requests for dues relief – and voted to approve both. Staff will send Council's recommendation to the APA.

Maryland Announces Overdose Response Strategy

The Moore-Miller Administration recently announced their updated Overdose Response Strategy, which identifies five goals for reducing overdoses and expanding access to substance use care. The new strategy replaces Maryland's previous Inter-Agency Overdose Coordination Plan and will guide the efforts of state agencies working to address substance use and overdose. The five strategic goals include:

- Interrupt Pathways to Substance Use Disorder:
 Expand efforts that address the social determinants of substance use and overdose risk while disrupting intergenerational cycles of trauma and growing youth-focused prevention programming.
- Improve Health and Safety for People Who Use
 Drugs: Empower people with the tools and knowledge
 to stay safe while building relationships that make it
 easier to make connections to care.
- Make Evidence-Based Treatment Accessible for People with Substance Use Disorders: Expand equitable access to evidence-based treatment for individuals with substance use disorder to ensure that anyone seeking treatment can access it whenever they need it regardless of circumstance.
- Build and Sustain Community Infrastructure That Promotes Recovery Capital: Increase structures of support that enable individuals to thrive.
- Improve Outcomes for People Who Use Drugs Who Encounter the Criminal Legal System: Decrease criminal involvement for people who use drugs and expand services for individuals who are already involved in the criminal legal system.

The plan was compiled using input from the Maryland Overdose Response Advisory Council, which is open to the public, chaired by Lt. Governor Aruna Miller and includes representatives of 18 state offices and agencies. Input from local Overdose Prevention Teams and community feedback from town halls held in each of Maryland's 24 local jurisdictions was also considered.

PDMP Refresher CME Course

A CE has been developed to explain the most recent updates in the Prescription Drug Monitoring Program (PDMP), including valuable clinical tools and reports available in the CRISP Portal. This webinar is now available on the MedChi website. Dr. Gary Pushkin, has an insightful perspective in this area through his work with the Opioid Task Force at MedChi, which has now evolved into the Opioid Pain and Addiction Committee. View link here. Legislative Update

There are only a few working days left in the 2025 General Assembly – below is the current status of some of the legislation on which the MPS Legislative Committee took positions:

Supported Legislation:

<u>SB 509/HB 592: Prohibited Possession of Firearms – Assisted</u> <u>Outpatient Treatment Respondents:</u>

HB 592 crossed to the Senate with little discussion before the cross-over date of March 17th. Therefore, because SB 509 already had a hearing, Judicial Proceedings Committee (JPR) may choose not to have a hearing but instead place the bill on a voting list. The goal is to get the bill voted to the Senate floor before the end of the session.

HB 1480: Child Advocacy Centers – Continuity of Care Standards for Health Care Professionals and Reports of Violations: Bill crossed over to the Senate and will be heard on 4/1

SB 900/HB 1146: Maryland Behavioral Health Crisis Response System: Both bills have crossed over and the Senate bill was heard in the House on 3/26. No date has been proposed for the House bill to be heard in the Senate.

<u>SB 372/HB 869: Preserve Telehealth Access Act of 2025:</u> Both bills crossed over and have both been heard in the opposite body.

Opposed Legislation:

SB 926/HB 1328: End-of-Life Option Act: There was a vigorous two-and-a-half-hour debate in a joint House hearing with the Health and Government Operations and Judiciary Committees. The Senate hearing in the Judicial Proceedings Committee was canceled by the sponsor. Therefore, this bill is likely to fail.

Maryland Loan Repayment Program 2025 Application Cycle

We are pleased to announce opening of the Maryland Loan Repayment Program (MLRP) 2025 application cycle! MLRP applications will be accepted from eligible applicants from March 1 — April 15, 2025. Applications will be completed utilizing tools available on the Application section of the program website. You can find program eligibility criteria, application instructions, and all application documentation on the site. If you plan to apply, we strongly encourage you to read the application instructions and connect with your application contributors (employer and professional references) well in advance of application deadlines.

MDH Expands Access to School-Based Mental Health Services

The Maryland Department of Health has made it easier for families on Medicaid to access mental health services in schools for their children. The expansion allows Local Education Agencies to offer certain behavioral health services to all students enrolled in Medicaid. Previously, Medicaid payment for these services was limited to Medicaid-enrolled students who have an approved Individualized Education Program (IEP) or Individualized Family Service Plan (IFSP).

The updated policy now allows all Maryland public K-12 schools to bill Medicaid for children enrolled in the program that receive diagnostic evaluations, individual therapy, family therapy, and group therapy. These services are provided by licensed school psychologists and school social workers. Licensed school psychologists are a new Medicaid provider type under this expansion.

Currently, Local Education Agencies are reimbursed for mental health services only when provided to students enrolled in Medicaid with an approved IEP or IFSP. Under the new plan, all students enrolled in Medicaid will have access to these vital services.

Maryland PDMP Academic Detailing Program

The Academic Detailing Program (provided through Maryland's Prescription Drug Monitoring Program (PDMP) and the University of Maryland School of Pharmacy's Behavioral Health Resources and Technical Assistance (BHRT) Program) provides free 1:1 educational outreach for medical providers to help increase prescribers' and pharmacists' use of evidence-based recommendations for opioid prescribing, opioid safety, and implementation of best practices. Trained outreach educators share best practices, resources, and tools to help streamline workflow and improve patient outcomes. Training is provided either virtually or in person. Prescriber Buprenorphine Access Survey

As part of an ongoing effort to understand the landscape of buprenorphine access, Maryland Addiction Consultation Service (MACS) is surveying prescribers across Maryland. The RFAs are the first grant opportunities offered through the recently developed Center for Firearm Violence Prevention and Intervention. The Center for Firearm Violence Prevention and Intervention was established in 2024 as part of the Moore-Miller Administration's commitment to creating a safer Maryland for all. The Center aims to reduce firearm violence, mitigate the harm caused by firearm incidents and address firearm misuse in the state. To achieve the goals, the Center collaborates with federal, state, and local agencies and affected communities to implement a public health approach to reduce firearm violence.

Ikwunga Wonodi Social Justice and Health Equity in Psychiatry Award

Annually, the Ikwunga Wonodi Social Justice and Health Equity in Psychiatry Award honors a Resident, Fellow, or Early -Career Psychiatrist who has demonstrated distinction in advocating for human rights and equity in psychiatric care for people with severe mental illness from historically marginalized and underserved communities through teaching, research, clinical work, and/or public health advocacy. The honor is designed to reflect Dr. Wonodi's values and contributions to psychiatry and the community.

This year, the Community Psychiatry & Diversity Coalition has selected Dr. Brandon C. Newsome as the first recipient of the award.

Dr. Brandon C. Newsome is a Child, Adolescent, and Adult Psychiatrist with a specialty in trauma related disorders, neurodevelopmental concerns such as autism, and medical conditions and their interplay with behavioral health. He currently serves as a School Psychiatrist for the Sheppard Pratt Prince George's and Montgomery County schools. In addition, he serves as the Medical Director in the Newport Academy Rockville Outpatient Program. As a continued community leader, he works with numerous organizations to promote behavioral health education and access. He also serves on the town of Bladensburg's Ethic's Commission. He continues his work locally as one of the Early Career Psychiatry representatives, and an Assembly Delegate for his regional child psychiatry association. He serves on the legislative committee for the Maryland Psychiatric Association. Currently he serves as a member of the Community Psychiatry Scientific Program Committee (previously Mental Health Services Conference), an APA Health Equity Ambassador, on the AACAP Adolescent Psychiatry Committee, and on the AACAP Diversity and Culture Committee (co-chair as of Oct 2024). He was a prior APA/ SAMHSA Minority Fellow and previously served on the APA Council on Children, Adolescents, and their Families, the APA Presidential Taskforce on Structural Racism Resource Workgroup, and the APA Presidential Taskforce on Social Determinants of Mental Health Workgroup on Research and Education.

Medicare Updates

MIPS Data Deadline April 14

The <u>deadline for 2024 Merit-based Incentive Payment</u>
<u>System</u> (MIPS) data submission is extended to **April 14**. Be sure to sign in at the <u>Quality Payment Program site</u> to submit and review your 2024 data by the deadline.

In response to the ongoing national IV fluid shortage, CMS will reopen the 2024 MIPS Extreme and Uncontrollable Circumstances (EUC) Exception Application to provide relief to practices impacted by the IV fluid shortage. The application will reopen Monday, March 31, 2025, at 10 a.m. ET, and will close April 14, 2025, at 8 p.m. ET.

Check whether you're currently required to participate in MIPS by entering your 10-digit National Provider Identifier (NPI) into the <u>QPP Participation Status Tool</u>. The participation threshold in 2025 remains:

- Bill more than \$90,000 a year for professional services under Medicare; AND
- Furnish services to more than 200 Medicare Part B beneficiaries; AND
- Provide more than 200 services under Medicare.

Opioid Use Disorder

Medicare pays for opioid use disorder (OUD) screenings performed by physicians and non-physician practitioners including:

- Evaluation and management visits for medication management
- Office-based substance use disorder (SUD) treatment services
- Opioid Treatment Program: Provide medications for opioid use disorder

Join Statement on Federal Concerns About Psychotropic Medication Safety

The safety and efficacy of traditional antidepressants, antipsychotics, and mood stabilizers (such as lithium and some anticonvulsants) and stimulant medications have been established through decades of rigorous research, randomized clinical trials, peer-reviewed studies, meta-analyses, national registry studies of thousands of people, post-marketing pharmacovigilance monitoring, and FDA oversight.

The February 14, 2025, Executive Order 14212, establishing the Make America Healthy Again Commission casts doubt on this research by tasking the Commission with "assessing the prevalence of and threat posed by the prescription of selective serotonin reuptake inhibitors (SSRIs), antipsychotics, mood stabilizers, stimulants, and weight-loss drugs".

These drugs provide relief for many young people enabling them to participate fully in treatment, school, social activities, and family life - all key aspects of healthy development. Efforts to discourage, stigmatize or curtail the use of evidence-based treatments for mental illness will have serious deleterious consequences, particularly for individuals with serious mental illness, their loved ones, and the communities in which they live.

Inaccurate information about the safety and efficacy of FDA-approved psychotropic medications has been amplified by misleading statements that antidepressants are addictive and pose hazards comparable to Schedule I narcotics. Like any medical treatment, psychotropic medications require monitoring. When used appropriately, these medications can stabilize serious mental illness, reduce suffering, shorten periods of disability, and save lives. Physicians work closely with patients and families to assess the risks and benefits of psychopharmacology and monitor for potential side effects, ensuring each patient receives individualized care.

Statistics on youth suicide further underscore the dangers associated with false information about safe treatments. Following the FDA's 2004 boxed warning highlighting the risk for suicidal behavior in younger depressed patients taking serotonin reuptake inhibitors, suicide rates increased, by as much as 60 percent in untreated youth with major depression. Truther, post-mortem toxicology studies suggest that many suicide victims with known mental health conditions do not have detectable levels of psychotropic medications in their system, further pointing to the hazard of undertreatment as a modifiable risk factor. Psychiatric medications are safe, effective, and can be lifesaving if they are taken properly-- as directed --under the care of an appropriately licensed healthcare professional. These medications can significantly improve the quality of life for children struggling with mental health conditions, including those at imminent risk of suicide, by helping to

alleviate symptoms of depression, mania, anxiety, obsessive-compulsive disorder, Tourette's disorder, ADHD, and psychotic illness.

We urge the Federal government and our colleagues within the scientific and practitioner communities not to disregard the critical role played by the appropriate use of evidencebased psychotropic medications in the treatment of individuals with psychiatric conditions that carry inherent high risks for suicide or other dangerous or life-threatening behaviors.

Statement on Gender Dysphoria and Military Readiness

APA issued the following statement on February 28th: "Whether an individual with gender dysphoria is able to meet the "high standards for service member readiness, lethality, cohesion, honesty, humility, uniformity, and integrity," quoted in Executive Order 14183 and a subsequent memorandum issued by office of the Undersecretary of Defense on Feb. 26, is a medical, not a political decision and, like other fitness determinations, should be made on a case-by-case basis. The data does not support the general conclusion that a diagnosis of gender dysphoria precludes an individual from meeting these standards or the rigorous mental and physical demands of military service."

APA Reaffirms Commitment to Mental Health Equity for All

In a statement, APA has said that it will continue to promote mental health care for individuals regardless of race, ethnicity, age, gender identity, sexual orientation, national or regional origin, religious orientation, and/or disability status. Statement on Reported Cuts to SAMHSA

The reported personnel cuts to the Substance Abuse and Mental Health Services Administration (SAMHSA) will inevitably lead to cutting programs and services that so many people with mental health and substance use disorders depend on. We are currently in a mental health and substance use crisis. SAMHSA's critical mission to "lead public health and service delivery efforts that promote mental health, prevent substance misuse and provide treatment and supports while ensuring access and better outcomes for all Americans" is more important now than ever.

SAMHSA's programs have contributed to the advances our nation has made in fighting the mental health and addiction crises. Its impact across the nation is widespread and crucial. Among other vital services, it provides education to the public on mental health, supports thousands of clinics with training in best practices, produces annual surveys with essential data points, and helps develop the future mental health workforce. In addition, it runs the national 988 Suicide & Crisis Lifeline, which took more than 14.5 million calls, texts, and chats in its first two years.

While the exact SAMHSA programs impacted are yet to be determined, many of these programs are lifesaving for our patients. Mental health has always been a bipartisan issue and must remain that way. Before taking any executive actions that will affect our nation's mental health, the American Psychiatric Association calls on the Administration and Congressional leadership to work with us and our partner organizations to thoughtfully pursue the best path forward to ensure people with mental health and substance use disorder do not lose services they desperately need.
