President's Column

The Powerhouse Duo of MPS and Their Perspective on the Direction of the Organization

For the month of December, I decided to take time to highlight the work of our administrative team by interviewing our Executive Director, Meagan Floyd and our Membership, Meetings, and Publications Coordinator, Jora Hritz. The goal in doing so was two-fold. First and foremost, I wanted to ensure that the entire membership had the chance to hear from the two individuals that do the vast majority of the work to keep MPS running. Secondly, I wanted to hear their perspective when discussing topics that affect the future direction of MPS.

In my conversation with Meagan, we reflected on the history of MPS. Meagan has been with the organization for 23 years and offers a unique perspective on how the organization has changed. In particular, we discussed the current challenge of representing and attending to all members while also advocating for the practice of psychiatry and the needs of our most vulnerable patient groups. As noted in the recent addition of *The Maryland* Psychiatrist, the APA is choosing to strike a balance in the current political climate by advocating for scientific fidelity but avoiding being an activist for broad social causes. This approach has received mixed reviews.

With Jora recently achieving her two-year anniversary with the organization, she was able to offer insight into managing competing demands when organizing meetings. Engaging early career members remains a challenge. Also, the post-pandemic struggle between in-person versus virtual meetings remains a dilemma.

As she noted, although many members request in-person, social engagement, virtual educational meetings for CMEs continue to be the most highly attended and least expensive to coordinate.

I welcome you to view our monthly video interview featuring both women. When thinking about what members want from the organization, the information that they offer might help manage expectations or inspire unique approaches in the future. Most importantly, I hope to demonstrate how hard they both work to support our organization. Their efforts will be front and center during the large, in-person CME that will be held on January 28, 2026 entitled the 2026 State of Psychiatry in Maryland. When you see them there, feel free to take a moment to say thank you.

November MPS Council Meeting Highlights

Consent Agenda

Dr. Balis noted the Council Minutes for the September meeting, MPS Committee Chair meeting minutes, Climate CME report, APA Board of Trustees report and summary of actions and the November Executive Director's report. She reminded members with any outstanding disclosure forms to please complete them as soon as possible.

Support for Strategic Priorities

Dr. Balis provided an update on activities that support MPS Strategic Priorities. She reported that since September:

- Solicited support for November CME meeting
- Shared WPS meeting notices with MPS members
- Advertised MPS paper and poster contest to RFM and ECP members
- Distributed information on APA Fellowships to RFM members
- Began planning RFM trivia night for 2026
- Began planning collaborative in-person CME event for winter 2026

Executive Committee Report

Dr. Means presented the Executive Committee report. He reported that since the last Council meeting the MPS Published information regarding license renewals, Carelon update, Medicaid information due to government shut down and more in the MPS News. He noted that staff were working to schedule a meeting with Behavioral Health Administration representatives before the end of the year. MPS continues to share meeting and other information from allied organizations to MPS members in an effort to enhance collaboration. He noted that the annual October MPS Committee Chairs Meeting was held in person and Ms. Floyd is working to schedule the LAC 2026 kick off meeting for early December, and MPS will be hosting Advocacy Day in Annapolis in early 2026. Dr. Means concluded by noting that Jora celebrated her two-year anniversary with the MPS on November 1st! She is a great asset to the MPS, and we are lucky to have her!

Nominations & Elections Committee Report

Dr. Hackman presented the proposed 2026 election slate and asked for any additional nominations. Hearing none, Council closed the nominations and voted unanimously in favor of the proposal. Dr. Hackman then requested nominations from Council for the APA Assembly Rep and Nominations & Elections Committee vacancies, and noted some possibilities identified already. Due to an unexpected, last-minute candidate reconsideration the day of Council, the Nominations and Elections Committee did not identify an unopposed candidate to run for APA Assembly Representative. After discussion and a nomination from a Council member, two MPS members will run opposed for the one, open slot. One candidate's name will be removed from the list of Council nominations as they will be running for an Assembly position, and the Nominations and Elections Committee will work to identify an additional candidate. Council agreed to postpone the vote on the approval of the slate until more information can be gathered regarding changes that will need to be made. Ms. Floyd agreed to work with the Nominations and Election Committee to investigate this unique situation and provide a

complete slate for January's meeting.

MedChi Delegate's Report

Dr. Oviedo reported that the MedChi annual meeting began with a presentation titled "Good Nutrition, Good Health, and How to Get There: The Road to Better Preventative Medicine Health." Old Business

The Maryland Foundation for Psychiatry re-presented the name for an appointment to their current Board of Directors. After much consideration and discussion, the nominee was not approved. Dr. Komrad will relay Council's discussion and decision to the Foundation Board members.

MPS Signs Onto Preauthorization Comment Letter

The MPS, along with 14 other organizations <u>signed onto a letter</u> which submitted comments on the Maryland Health Care Commission (MHCC) informal draft amendments to the preauthorization regulations, COMAR 10.25.17. Suggested changes included:

- Recommendation 1: Amend the definition of "internal coverage criteria" to align with Chapter 848 (Senate Bill 791)
- Recommendation 2: Explicitly identify in regulations the appropriate coverage criteria for MH and SUD benefits.
- Recommendation 3: Establish Clearer Policy Guardrails for the Use of Preauthorization, Concurrent Authorization, Step Therapy, and Quantity Limits, Consistent with Medicare Regulations

BHA Assisted Outpatient Treatment Comments Requested

The Maryland Department of Health (MDH) Behavioral Health Administration (BHA) is seeking informal public comment on draft Assisted Outpatient Treatment regulations ahead of the July 1, 2026 implementation date. There are public meetings to review the regulations on December 10th, 2025, 11.30a.m. - 1.00p.m. Please register for either meeting using this link. MDH welcomes informal public comments on the proposed regulations. Comments will be accepted through December 31st 2025; please use this link to submit written comments.

New AHEAD Model

Last month, Maryland officially signed the updated amendment to the AHEAD State Agreement with the Centers for Medicare & Medicaid Services (CMS), marking a major milestone for Maryland's long-standing, nation-leading value-based health care model. For more than a decade, Maryland's global budget and all-payer system has been the method to pay Maryland hospitals. The updated agreement ensures this model continues with major changes. The new AHEAD model sets ambitious statewide goals for decelerating healthcare spending, increasing investment in primary care, and improving population health. The agreement reflects months of detailed negotiations with CMS and strong engagement from Maryland's hospitals, payers, physicians, and other health system partners.

At a high level, the final agreement includes:

- Stability in the early years: only modest adjustments in 2026 and 2027, with CMS's new global budget methodology beginning in 202
- EQIP extended in perpetuity: A major win for physicians and the stat
- Protection of Maryland's global budget system: CMS and Maryland reaffirm the all-payer model and commit to a smoother, phased transition to the updated CMS global budget framework
- Greater flexibility on choice and competition requirements, including extended implementation timelines
- Alignment with Medicaid: creating a pathway for Medicaid rates to track with Medicare global budget rates as federal rulemaking progresse
- Lower threshold for services under global budgets: reduced from 90% to 85%, while retaining the ability for Maryland to set Maryland-specific rates for certain carved-out services

Governor Moore has established a state regulatory working group to coordinate and resolve these issues, with a final set of recommendations due in June 2026.

MHCC Report: Pharmacogenomic Testing

Medicaid Work Requirements: APA Resources

H.R. 1 was passed on July 4, 2025, and includes significant funding cuts and policy changes to Medicaid and the ACA marketplace, physician payment, and medical student loans. Below is information to help you understand the impact of H.R. 1, specifically tying work requirements to Medicaid eligibility as well as resources for you to utilize in your advocacy to your state agencies and governor.

The Secretary of Health and Human Services (HHS) is required to issue an interim final rule on implementing and setting standards for community engagement requirements by June 1, 2026.

In addition, the Centers for Medicare & Medicaid Services (CMS) announced on July 17, 2025, that it would not approve or extend Section 1115 demonstration waivers for workforce initiatives, which use Medicaid dollars to fund job training or employment-related activities.

Medicare Updates

2026 Policy Changes for the Quality Payment Program

The Centers for Medicare & Medicaid Services (CMS) has issued its <u>Calendar Year (CY) 2026 Medicare Physician Fee Schedule (PFS) Final Rule</u>, which includes policies for the Quality Payment Program (QPP) for the 2026 performance year (PY) and beyond.

Below are some of the key QPP policies that CMS finalized:

Merit-based Incentive Payment System (MIPS) (General) We finalized policies for the 2026 performance period for the MIPS performance categories, which include:

- The addition of 5 new quality measures, substantive changes to 30 quality measures, and the removal of 10 quality measures.
- Changes to the Alternative Payment Models (APM)
 Performance Pathway (APP) Plus quality measure
 set to maintain alignment with the MIPS quality
 measure inventory.
- The establishment of a 2-year informational-only feedback period for new cost measures, allowing clinicians to receive feedback on their score(s) and find opportunities to improve performance before a new cost measure affects their MIPS final score.
- The establishment of a measure suppression policy for the MIPS Promoting Interoperability performance category and the Medicare Promoting Interoperability Program.
- The suppression of the Electronic Case Reporting measure for the current CY 2025 performance period/2027 MIPS payment year for the MIPS Promoting Interoperability performance category and the Medicare Promoting Interoperability Program.

Maintaining Stability in MIPS

 We maintained the current performance threshold policies, leaving the performance threshold set at 75 points through the 2028 performance year.

Advanced APMs

We added a determination of Qualifying APM
 Participant (QP) status at the individual level for all
 eligible clinicians in Advanced APMs, in addition to
 determinations at the APM Entity level. As part of the
 effort to simplify this process, we are also adding a
 calculation based on Covered Professional Services as
 the set of services used for QP determinations.

Medicare Participation for 2026

As you plan for next year, CMS reminds you:

- You're paid the full Medicare Physician Fee Schedule allowed amount. If you're a non-participating provider, Medicare pays 5% less than the Medicare Physician Fee Schedule allowed amount.
- Medicare pays you directly (on an assignment-related basis).
- Medicare forwards claim information to Medigap (Medicare supplement coverage) insurance (if any).

By December 31, 2025, all physicians, practitioners, and suppliers – regardless of their Medicare participation status – must decide whether to participate for CY 2026. You don't need to do anything if you're:

- Already participating in Medicare, and you want to continue your participation
- Not currently participating, and you don't want to participate

National Plan and Provider Enumeration System (NPPES) Taxonomy: Please check your data in NPPES and confirm that it still correctly reflects you as a health care provider with the appropriate taxonomy and correctly reflects your current practice address. Incorrect data in NPPES may lead to unnecessary inquiries about your credentials and delay enrollment with Medicare and health plans.

Medicare Updates

Medicare Claims Impacted During the Government Shutdown

Multiple expiring Medicare statutory payment provisions lapsed on October 1, 2025, due to the absence of Congressional action. With the passage of the Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act, 2026 (Pub. L. 119-37), Congress retroactively restored many of these payment provisions, effective from October 1, 2025, through January 30, 2026. This includes retroactively restoring the suspension of statutory provisions that restrict payment for telehealth services provided to beneficiaries in their homes and outside of rural areas.

During the shutdown, in general, the Medicare Administrative Contractors (MACs) processed claims consistent with the pricer software, fee, and payment schedules available on cms.gov. CMS has instructed the MACs to perform mass adjustments to any paid claims that are inconsistent with the most recent Congressional action, including a payment adjustment for low volume inpatient hospitals and a payment adjustment for the Medicare-dependent hospital program.

On November 6, 2025, CMS instructed the MACs (see Update on Processing of Telehealth and Acute Hospital Care at Home Claims) to return a subset of telehealth claims submitted on or before November 10, 2025, that, at that time, were no longer payable because the statutory provisions temporarily suspending various Medicare telehealth requirements expired on October 1, 2025, or were claims CMS could not identify as payable under current law. For professional claims, those claims were returned with the following messages: CARC 16 and RARC M77. These claims are now payable, provided they meet all applicable Medicare requirements. Practitioners may resubmit those returned claims to CMS, as well as submit any other telehealth claims held in anticipation of possible Congressional action. Practitioners are also encouraged to identify which beneficiaries were charged for telehealth services with dates of service on or after October 1, 2025, that are retroactively payable and instead submit applicable claims to Medicare, refunding any overpayment to beneficiaries. Their instruction to practitioners to append the GY modifier on certain telehealth claims is rescinded and providers may resubmit previously denied claims. Similarly, beginning on November 10, 2025, CMS instructed the MACs to return claims for the Acute Hospital Care at Home initiative for dates of service of October 1, 2025, or later. Hospitals may resubmit those claims to CMS.

AMA Releases 2026 Medicare Final Rule Summary

On Oct. 31, 2025, the Centers for Medicare & Medicaid Services (CMS) released the Calendar Year (CY) 2026 Payment Policies under the Medicare Physician Payment Schedule (PFS) and Other Changes to Part B Payment and Coverage Policies final rule, implementing significant payment policy changes that will take effect on Jan. 1, 2026.

To help physicians understand the impact of the final rule, the AMA developed a detailed <u>summary and analysis</u> (PDF), which explains how:

- All physicians will benefit from the positive conversion factor updates for 2026, including a 3.77% increase for advanced alternative payment model (APM) qualifying participants (QPs) and a 3.26% increase for all other physicians.
- For many physicians, the benefits of the positive update will be at least partially offset by the finalized practice expense and efficiency adjustment cuts, which are broken down in the summary.
- Physicians who treat hospital inpatients and nursing facility patients through telehealth, those who provide services requiring direct supervision, and teaching physicians who virtually supervise residents in the delivery of telehealth services will all benefit.
- Maintaining the Merit-based Incentive Payment System performance threshold to avoid a penalty at 75 points for the next three years introduces much-needed stability and predictability into a program that costs \$12,800 per physician per year to comply.

The analysis provides additional information about individual code changes and valuations, skin substitutes, geographic practice cost indices, the Medicare Diabetes Prevention Program, the Medicare Shared Savings Program, MIPS Value Pathways, and the Ambulatory Specialty Model, among others. The AMA has also developed a two-pager (PDF) to explain the problematic efficiency adjustment and practice expense payment policies. Telehealth Services Extended

Member Publications

Paul Nestadt, M.D. and Cynthia Major Lewis, M.D. published "Near-Term Risk for Psychosis and Non-Psychosis -Related Suicide: A Retrospective Examination of the Last 30 Days of Life." The retrospective exploratory study determines that for optimal clinical management and suicide prevention clinicians need a better understanding of near-term risk for suicide and to focus assessment and clinical care accordingly.

Haroon Burhanullah, M.D. co-authored a publication in the *American Journal of Geriatric Psychiatry* titled "A randomized controlled trial of the safety and efficacy of dronabinol for agitation in Alzheimer's disease." The study analyzed the safety of efficacy of dronabinol (THC) and determined that the drug may be relatively safe and effective in reducing agitation symptoms in people with moderate to severe AD.


