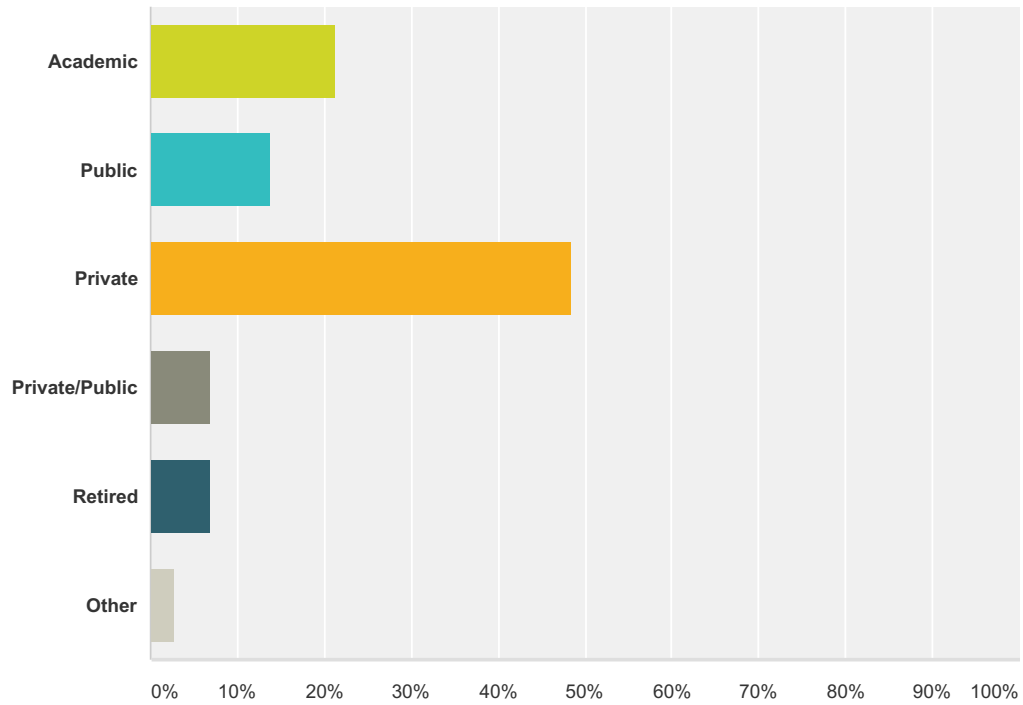

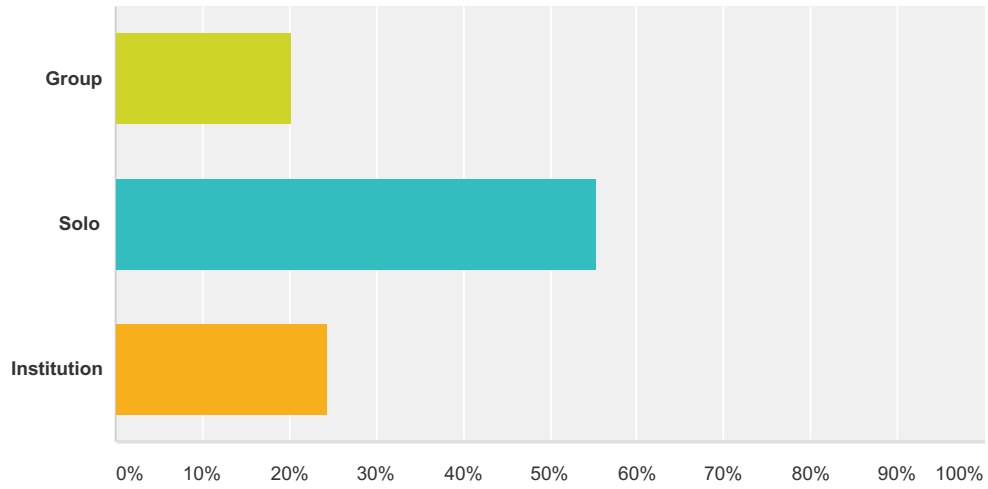

Q2 If you are in private practice, is it:

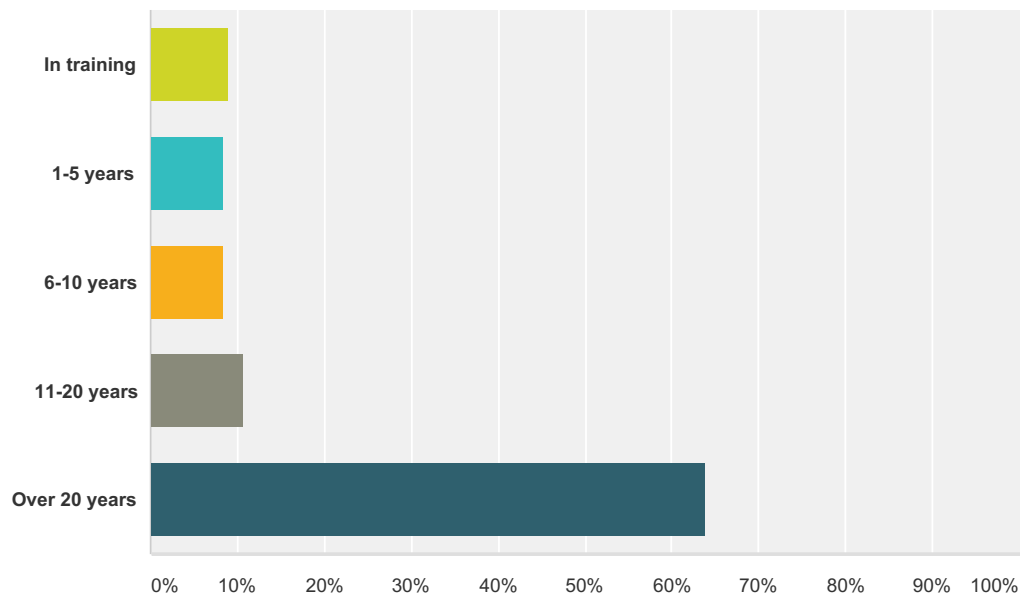

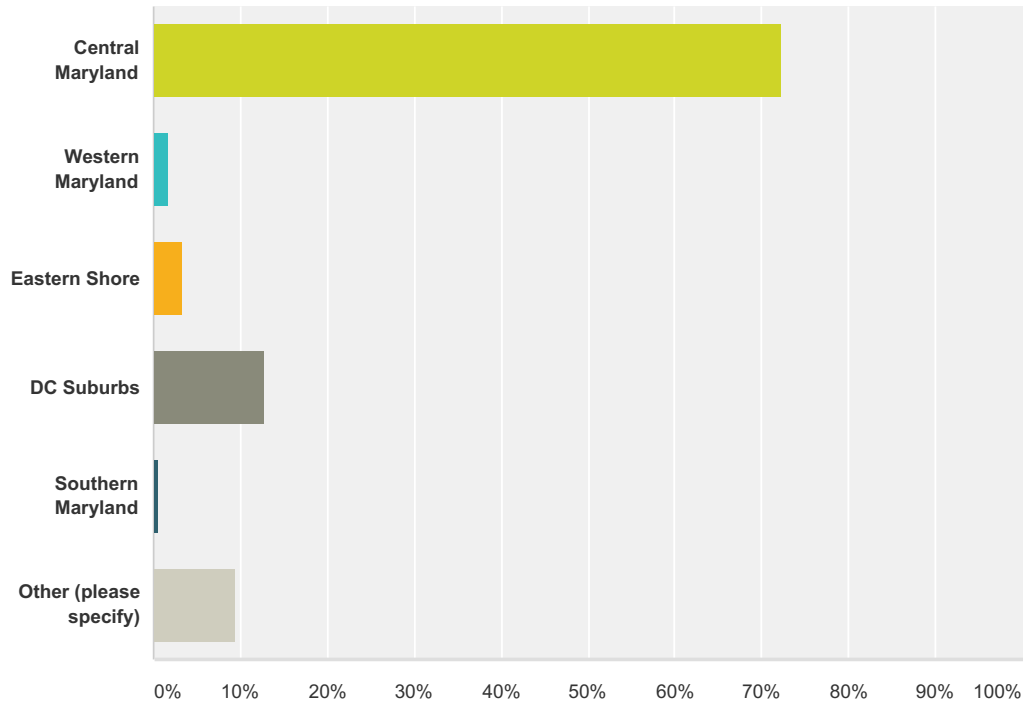

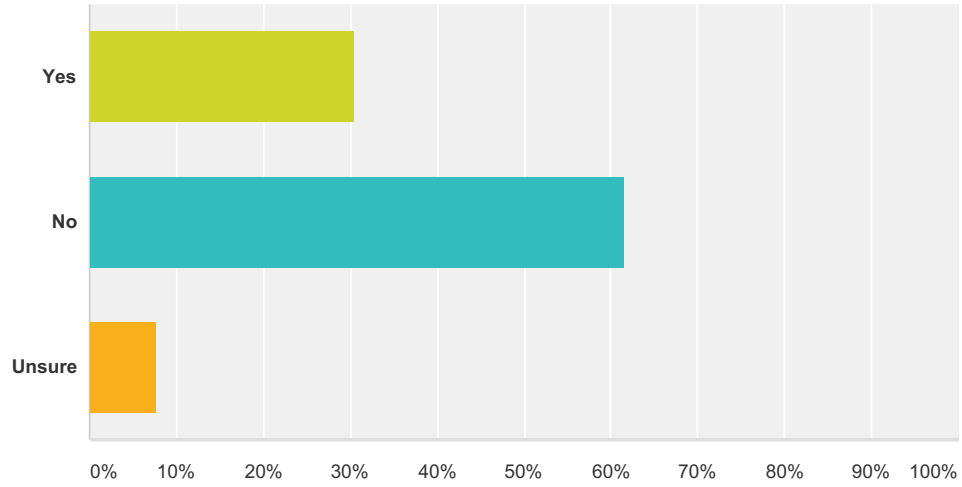

Q7 Have You Attended a MPS Sponsored EducationActivity In The Past Year?

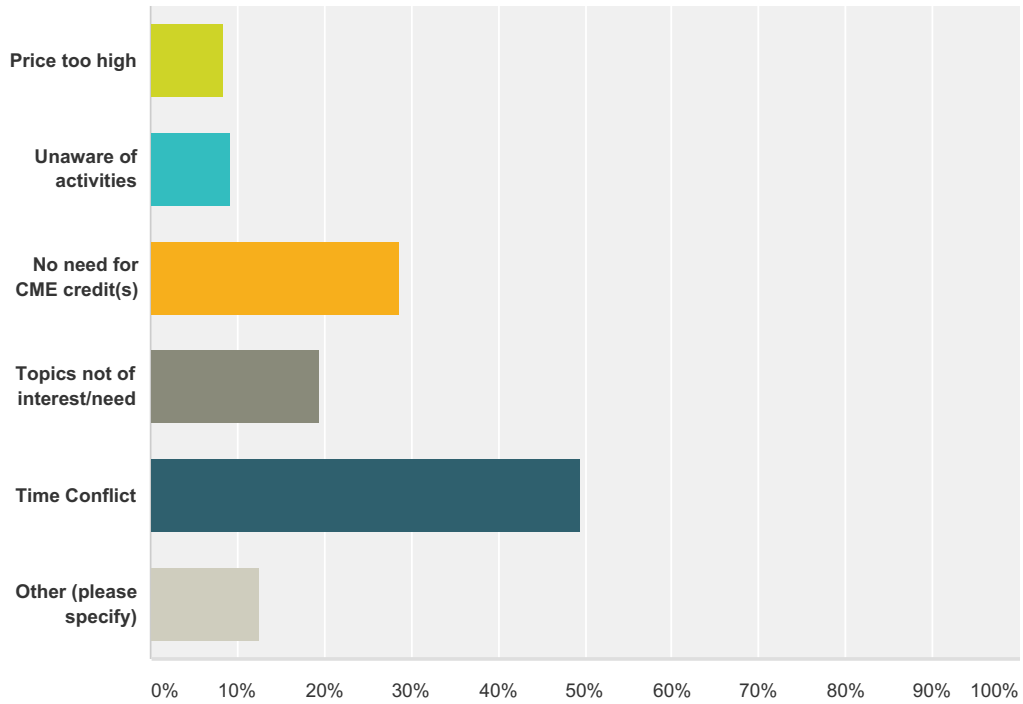

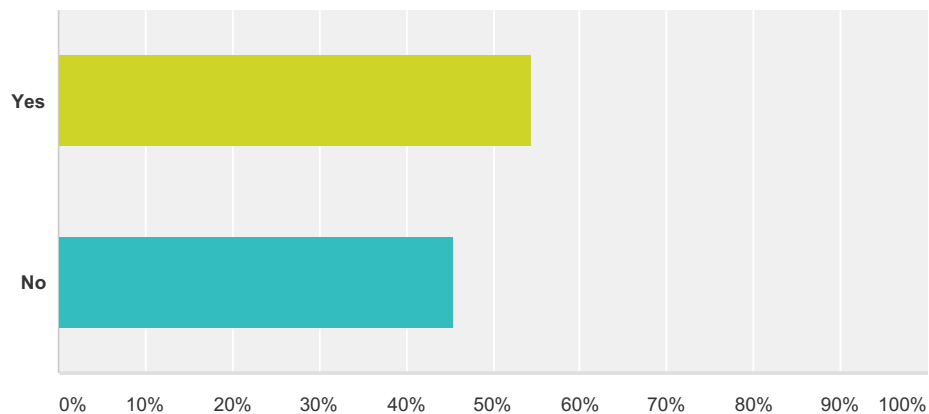

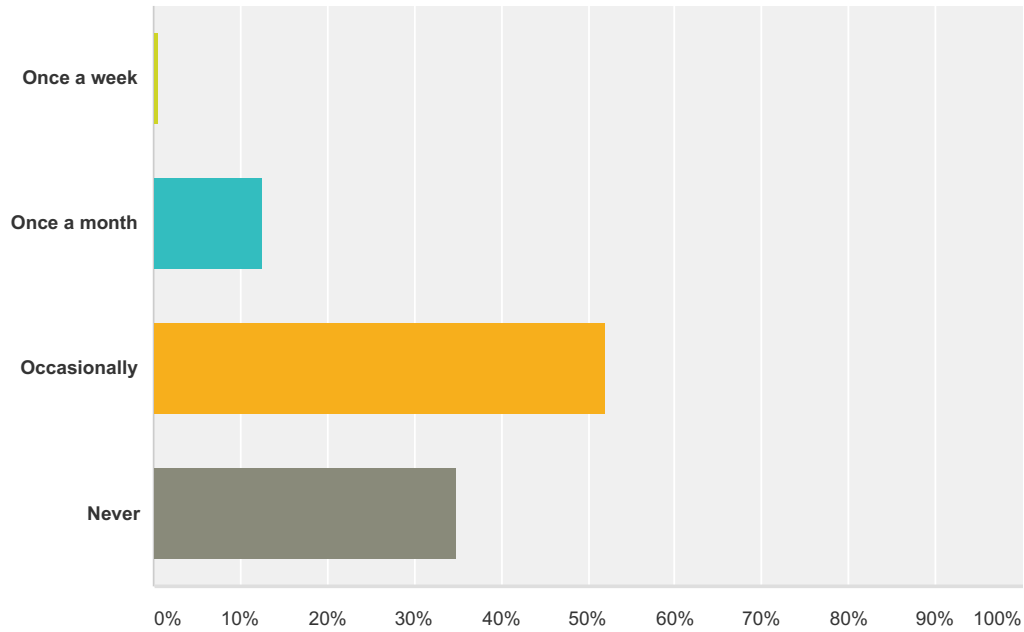

Q10 How Often Do You Visit The MPS Website?

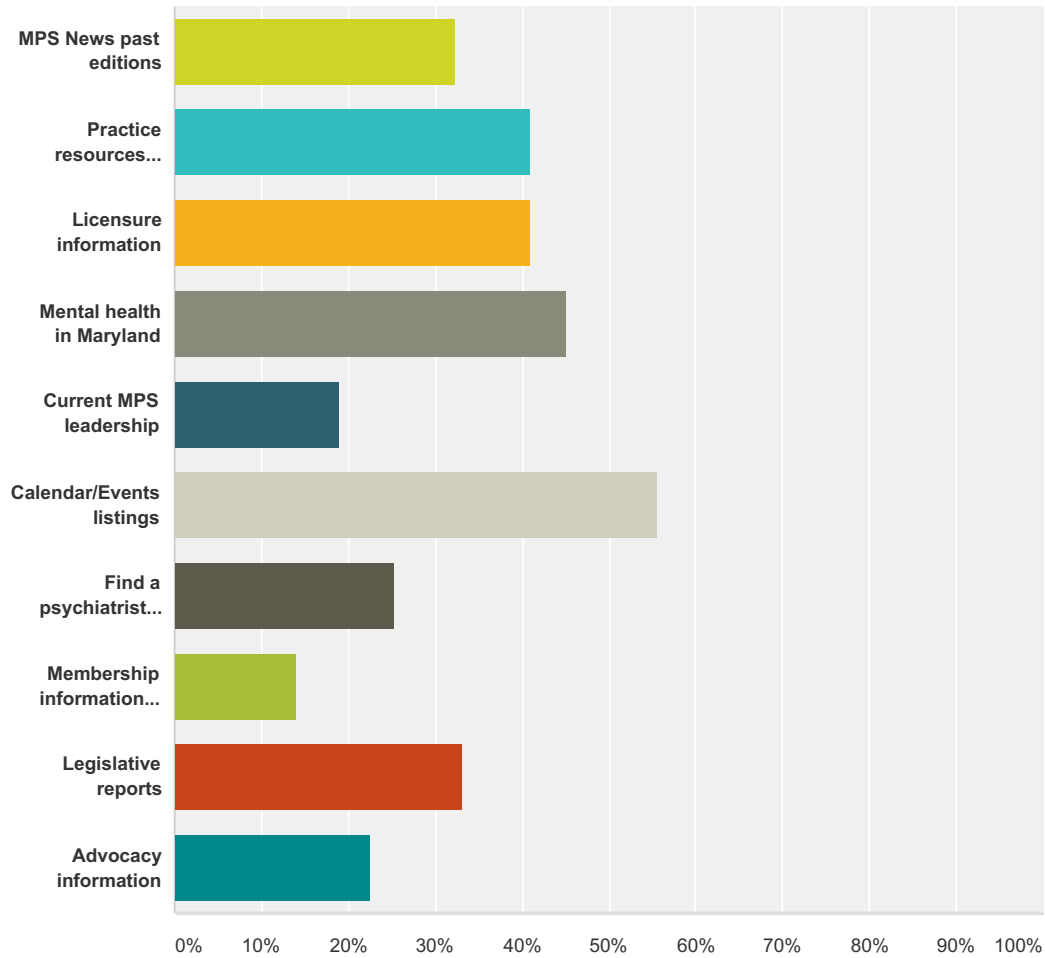

Q11 WhatMPS Website Content Is Of The MostInterest To You? (Please check all that apply)

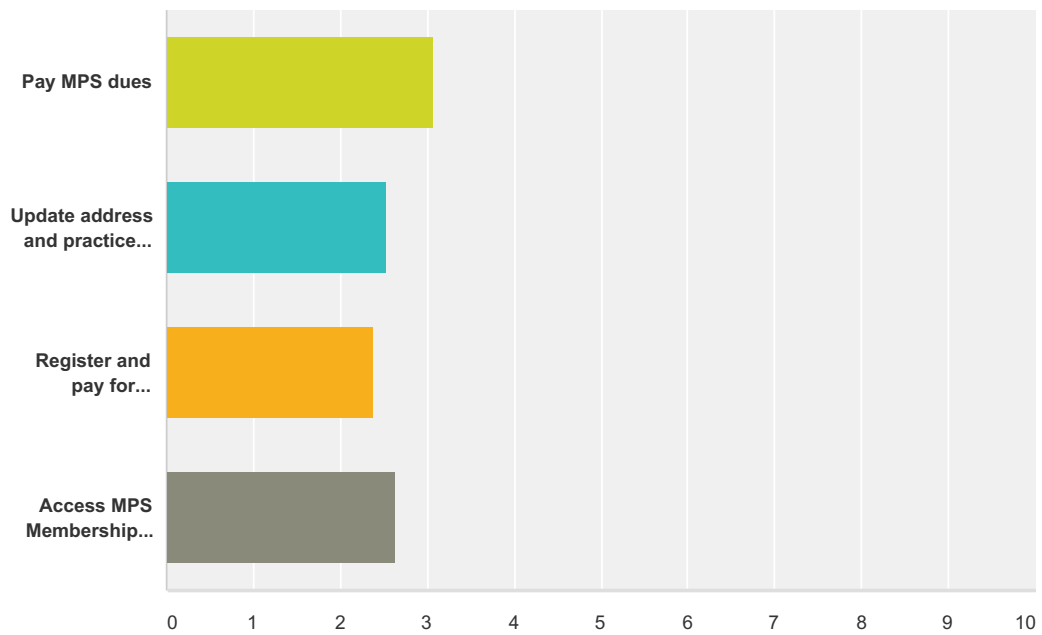

Q12 What Members-only Features Would You Like On TheMPS Website? (Please rank, 1=highest)

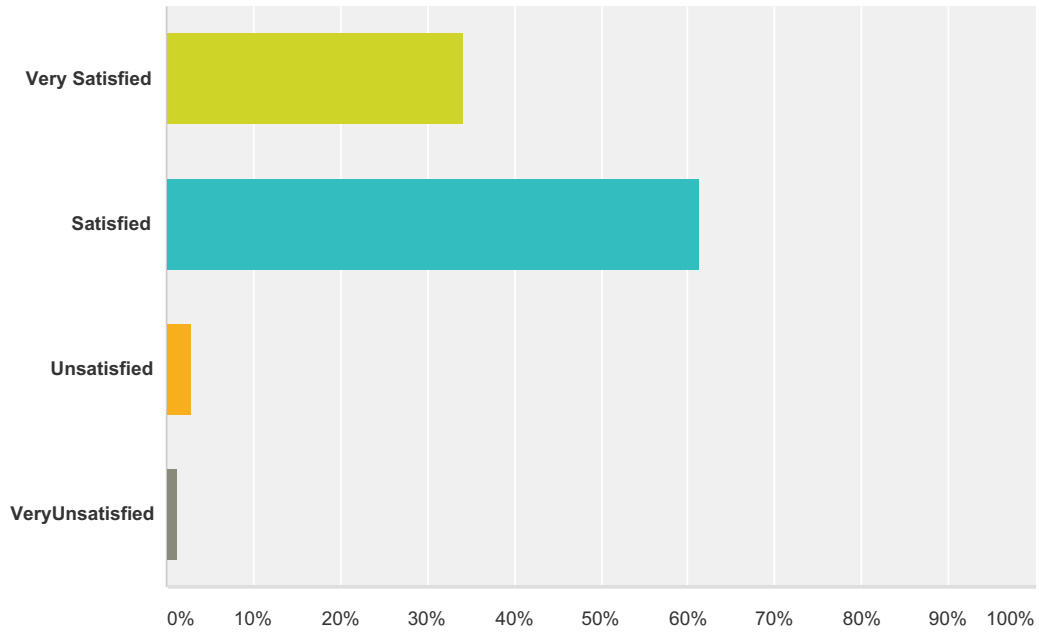

Q13 What Is Your Overall Level Of Satisfaction With The MPS?(please check one)

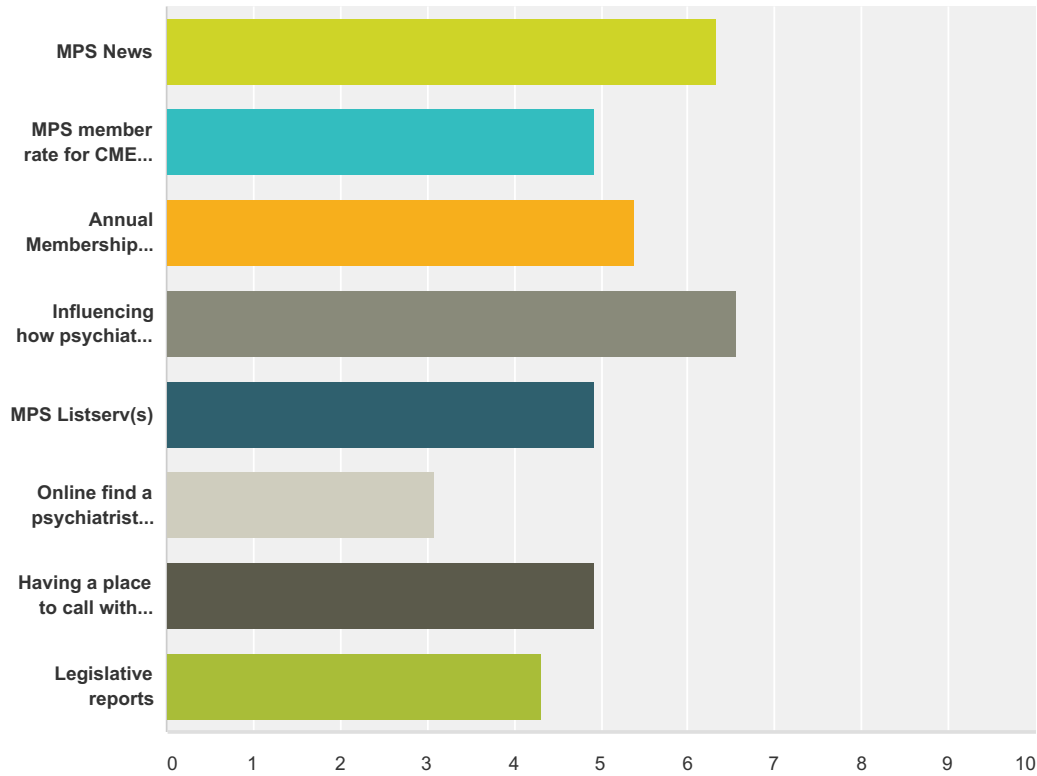
