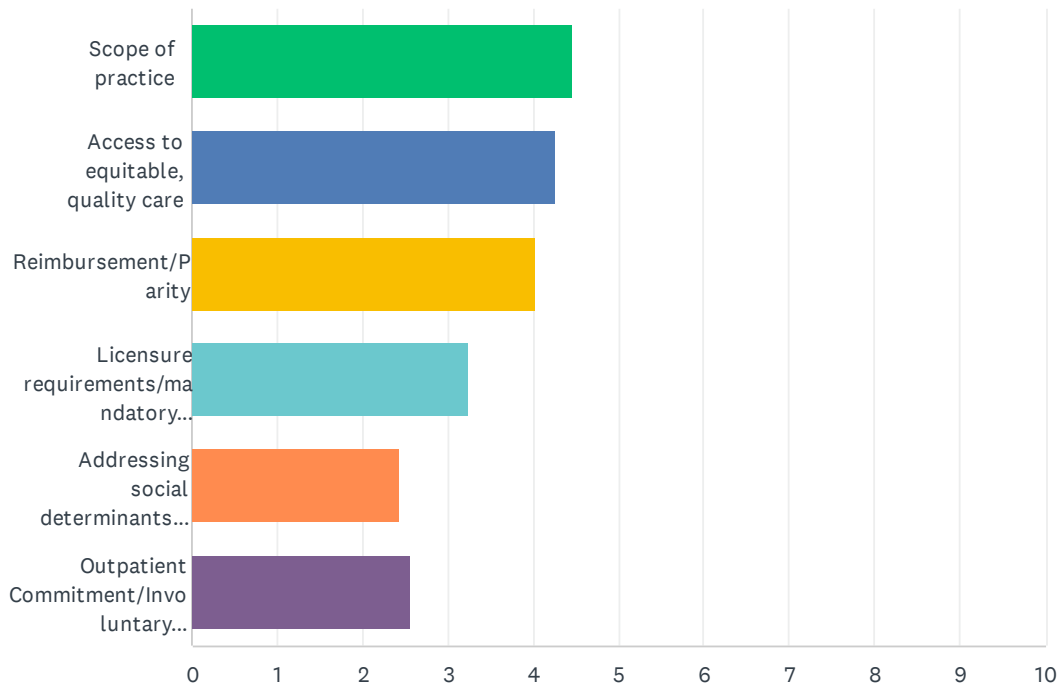

Q11 What is your overall level of satisfaction with the MPS?

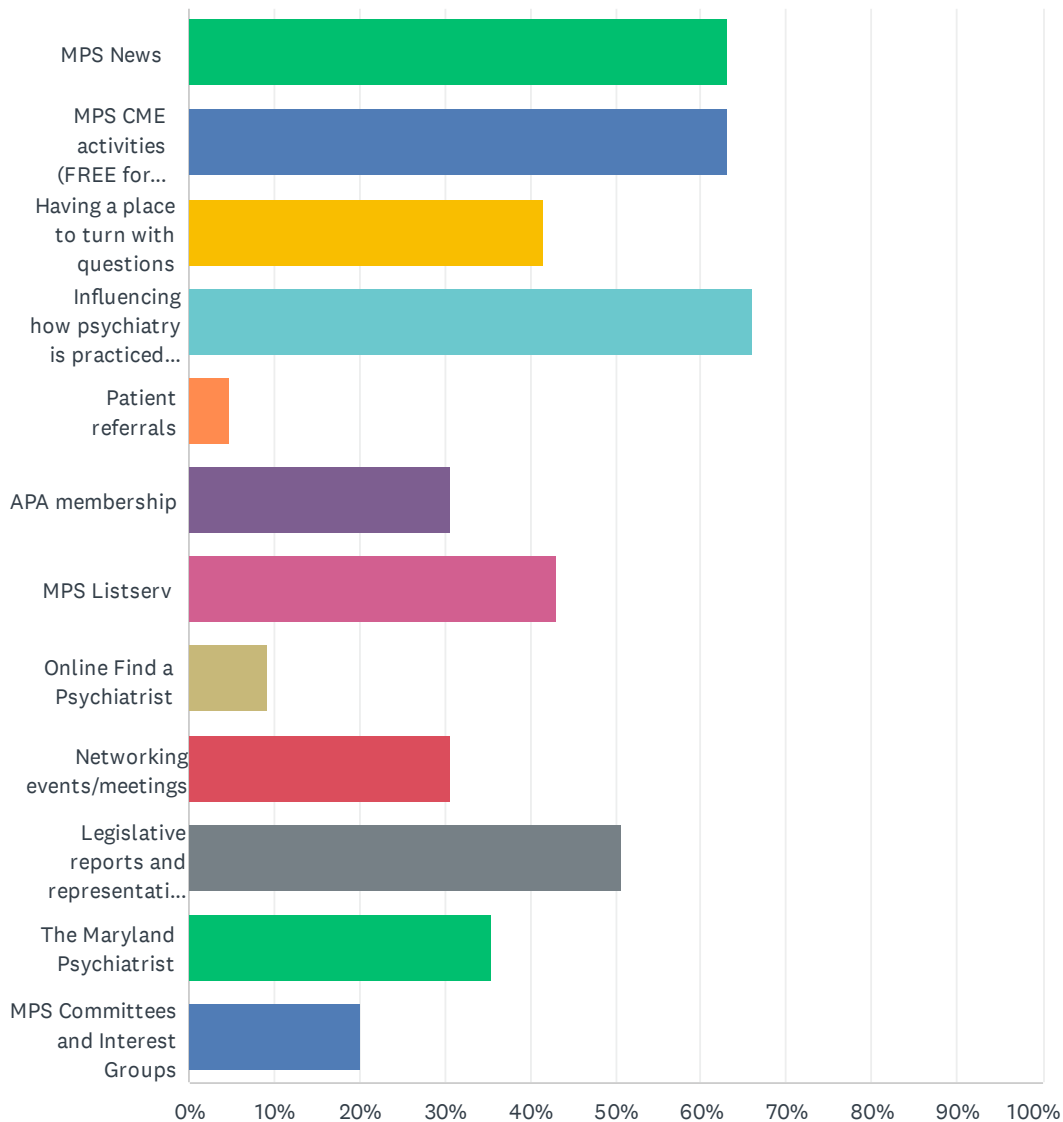

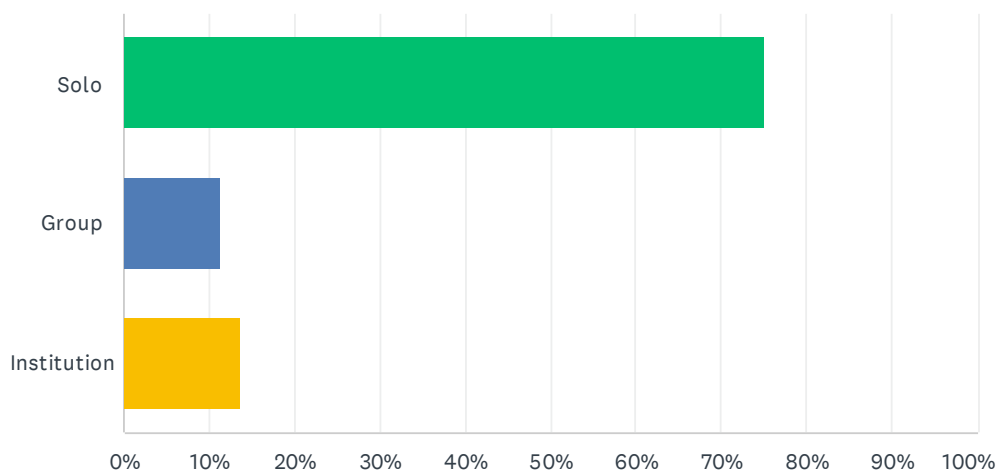

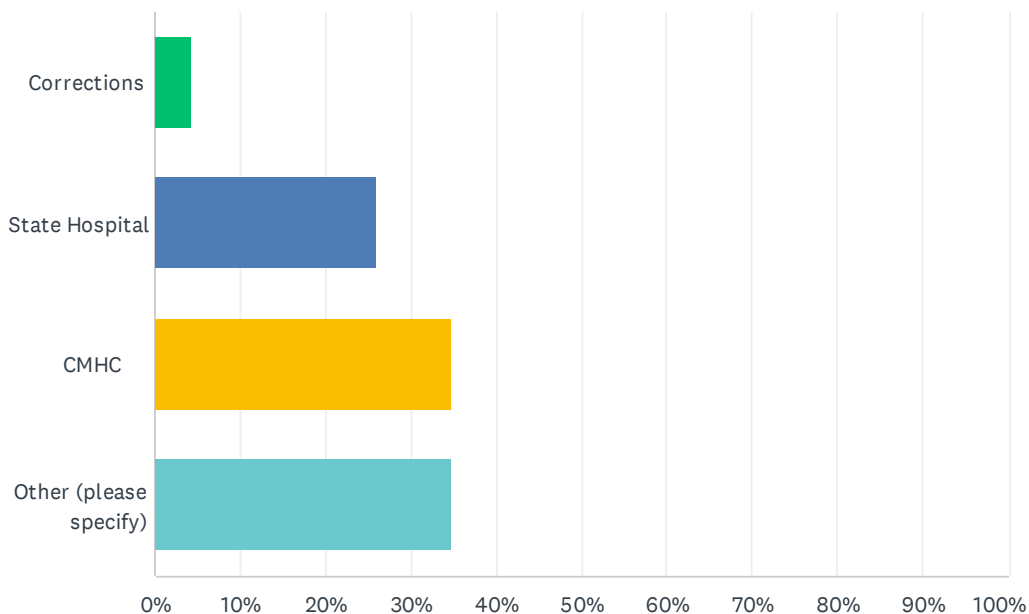

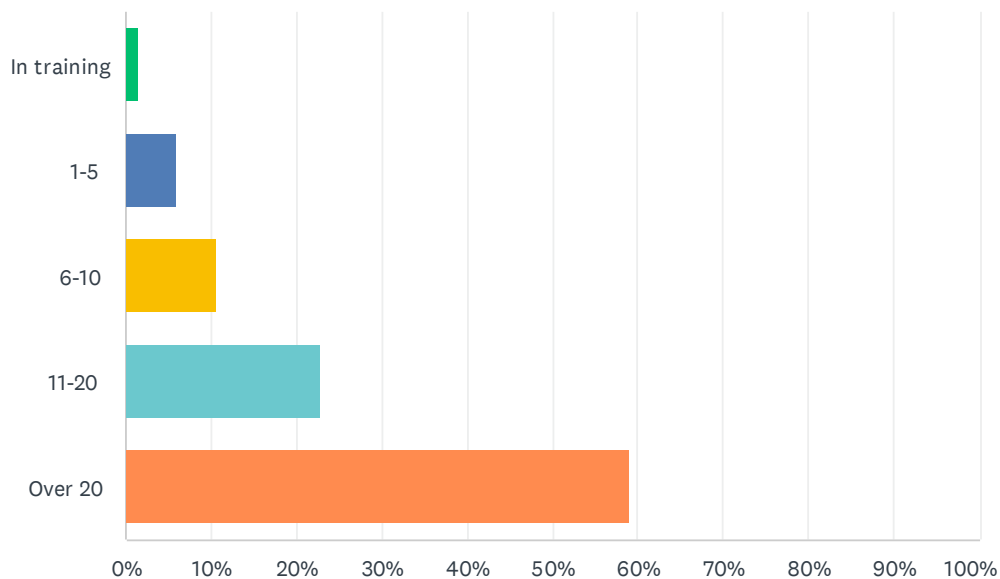

Q21 How long have you been in practice?

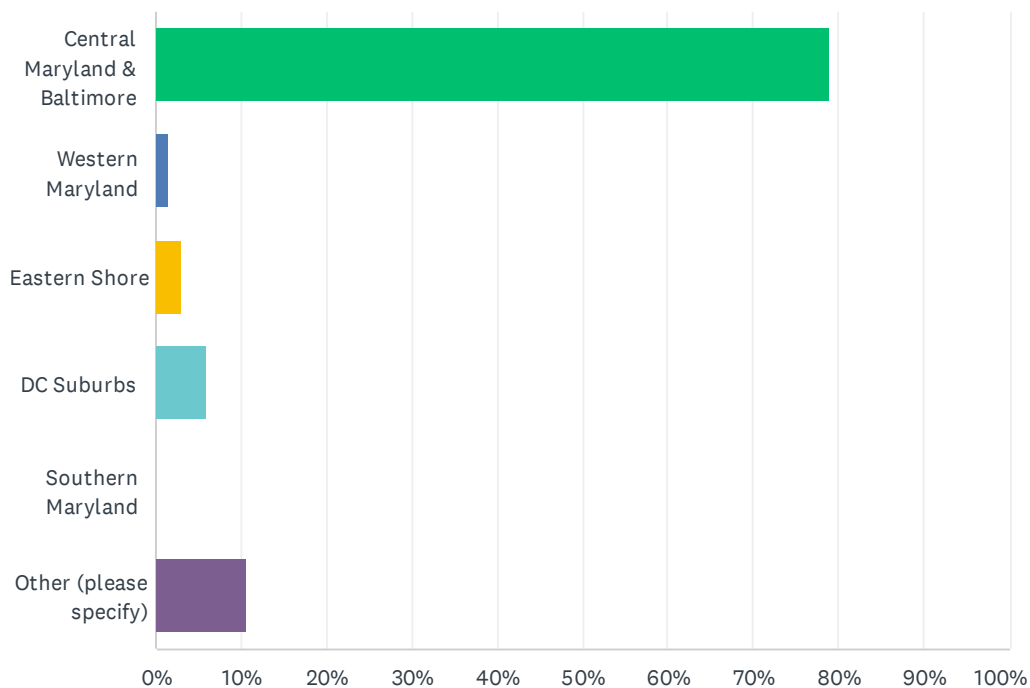
